

The general effect of the Order would be:

- (1) in respect of the Free Parking Places Order, to reduce the sizes of certain free parking places located in Coombe Road, Kingston and Woodbines Avenue;
- (2) to further amend the Kingston-upon-Thames (Waiting and Loading Restriction) (Special Parking Area) (No. 1) Traffic Order 1994, so that additional waiting restrictions, operating between 8 a.m. and 6.30 p.m., on Mondays to Saturdays inclusive, would be introduced into Coombe Lane West, Gloucester Road, Wolsey Close and Dumbleton Close and new waiting restrictions, operating between 7 a.m. and 7 p.m. on Mondays to Fridays inclusive, would be introduced into Coombe Lane West.

Copies of the proposed Orders, maps which indicate the locations and effect of the Orders, copies of the Kingston-upon-Thames (Waiting and Loading Restriction) (Special Parking Area) (No. 1) Traffic Order 1994, and the Kingston-upon-Thames (Free Parking Places) (Special Parking Area) (No. 1) Order 1994, and the Council's statement of reasons for proposing to make the Orders, can be inspected between 9.30 a.m. and 4.30 p.m., on Monday to Fridays inclusive, until the end of 6 weeks from the date on which the Orders are made or, as the case may be, the Council decides not to make the Orders, in:

- (a) the 2nd Floor Reception Area, Guildhall 2, Kingston-upon-Thames, Surrey; and
- (b) the Kingston Library, Fairfield Road, Kingston-upon-Thames, Surrey.

## NEW ROADS AND STREET WORKS ACT

### SUFFOLK COUNTY COUNCIL

#### NEW ROADS AND STREET WORKS ACT 1991, SECTION 58

##### *Notice of Substantial Road Works*

Three months' advance notice is hereby given that Suffolk County Council as Highway Authority intends to carry out substantial works for road purposes.

2. The street in which these works will take place is:

A1101 Carriageway and Footway resurfacing.

- (i) Bury Road, Mildenhall;
- (ii) Kingsway and Old Police Station Square, Mildenhall;
- (iii) Beck Row Street;
- (iv) Kenny Hill.

3. Work is expected to affect the carriageway and both footways between:

- (i) A11 roundabout to Lark Road;
- (ii) Croft Place to northern limit of Old Police Station Square mini roundabout;
- (iii) From the C602 Eriswell Road to the C603, the road to Weston;
- (iv) From U6020 Kenny Hill Drove to Old Rising Sun Bridge.

4. Work is expected to commence on 9th June 1997 (work should begin within one month of this date).

5. The works notified will include the following:

- (i) 7,000 square metres of carriageway surfacing and 1,200 square metres of footway resurfacing. A11 roundabout to Lark Road;
- (ii) 4,000 square metres of carriageway surfacing and 900 square metres of footway resurfacing, Croft Place;
- (iii) 27,000 square metres of carriageway surfacing and 7,000 square metres of footway resurfacing from C602 Eriswell Road to C603 the road to Weston.

- (iv) 6,500 square metres of carriageway resurfacing U6020 Kenny Hill Drove to Old Rising Sun Bridge.

6. Subject to the exemptions in the Act and Regulations under it, no street works may be executed on or after the date given in paragraph 4 above, without the consent of the said Suffolk County Council, which shall not be unreasonably withheld.
