A Statute made by the Governing Body of Trinity College, Cambridge, on 14th March 1997, amending Statutes XVII and LXVI has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provision of the Universities of Oxford and Cambridge Act 1923

The purpose of the Statute is to widen the basis on which elections to Honorary Fellowships may be made and to give the College greater flexibility to alter Trusts of which the College is Trustee.
