

- (b) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited:
- (i) at any time throughout the week in the length of Grove Road West specified in Schedule 5 to this notice;
 - (ii) between 8 a.m. and midnight throughout the week in the length of Ordnance Road specified in Schedule 6 to this notice;
 - (iii) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 7 to this notice;
- (c) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle:
- (i) would be prohibited:
 - (A) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 8 to this notice;
 - (B) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the lengths of Cedar Avenue specified in Schedule 9 to this notice;
 - (ii) unless, prohibited as above, for a period of more than 20 minutes in the same place would be prohibited:
 - (A) between 11 a.m. and 6.30 p.m. throughout the week in the lengths of streets referred to in sub-paragraphs (b) (i) and (ii) above;
 - (B) between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets referred to in sub-paragraph (b) (iii);
- (d) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraph (b) above would be prohibited, except on a Sunday, unless there is in force a valid licence issued by Enfield Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (e) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the lengths of streets referred to in sub-paragraph (b) above, would be prohibited;
- (f) the hours during which the existing prohibition on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be changed so that it would apply:
- (i) at any time throughout the week in the lengths of streets specified in Schedule 10 to this notice;
 - (ii) between 8 a.m. and midnight throughout the week in the length of Hertford Road, Enfield, specified in Schedule 11 to this notice;
 - (iii) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 12 to this Notice;
- (g) the hours during which the existing prohibition on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be changed so that it would apply:
- (i) at any time throughout the week in the length of Hertford Road, Enfield specified in Schedule 13 to this Notice;
 - (ii) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 14 to this Notice;
- (h) any existing restrictions in the lengths of Aylands Road and Cedar Avenue specified in Schedule 7 to this Notice on waiting by vehicles, on the sale of goods and on advertising activities imposed by the above-mentioned Order of 1994 would be revoked;
- (i) the length of Hertford Road, Enfield specified in Schedule 15 to this Notice would be excluded from classification as "Urban Clearway".
4. The prohibitions referred to in paragraph 3(b) and (c) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a parking attendant or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol etc., from roadside petrol stations; to licensed street traders, etc.
5. The general effect of the Restriction of Waiting on Bus Stops Order would be to:
- (a) prohibit all vehicles from stopping:
 - (i) at any time throughout the week on the area of carriageway of Green Street specified in Schedule 16 to this Notice and which area would be marked on the carriageway by a yellow "bus stop" marking and by a solid yellow line;
 - (ii) between 7 a.m. and midnight throughout the week on the areas of carriageway of the streets specified in Schedule 17 to this Notice and which areas would be marked on the carriageway by a yellow "bus stop" marking and by a solid yellow line;
 - (iii) between 7 a.m. and 7 p.m. throughout the week on the areas of carriageway of the streets specified in Schedule 18 to this Notice and which areas would be marked on the carriageway by a yellow "bus stop" marking and by a solid yellow line;
 - (b) any existing restrictions in the lengths of streets referred to in sub-paragraph (a) above on waiting by vehicles imposed by the Enfield (Restriction on Waiting on Bus Stops) (Special Parking Area) (No. 1) Traffic Order 1994 would be revoked.
6. The prohibitions referred to in paragraph 5 above would not apply:
- (a) to a bus, whilst picking up or setting down passengers; or
 - (b) to a taxi, whilst picking up or setting down passengers; or
 - (c) to a vehicle being used for ambulance, fire brigade or police purposes; or
 - (d) in certain circumstances, to a vehicle being used in the service of a local authority, to a vehicle being used in connection with building operations, etc., adjacent to the bus stop or the removal of any obstruction to traffic or the repair, etc., of the highway or of any service therein; or
 - (e) where the person in control of the vehicle is required by law to stop, or does so in order to avoid an accident; or
 - (f) to anything done with the permission of a police constable in uniform, a traffic warden or a parking attendant.
7. The general effect of the Free Parking Places Order would be to:
- (a) designate free parking places (no time limit) in lengths of the service road fronting Nos. 520 to 560 Hertford Road specified in Schedule 19 to this Notice;
 - (b) provide that the parking places would be in operation between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
 - (c) specify, that in respect of the parking places, that passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles or invalid carriages may be left therein;
 - (d) provide that certain other vehicles may wait in the parking places in certain circumstances.
8. The Parking Places Orders will come into operation for the purposes of marking on the carriageway of parking spaces and the placing of traffic signs, etc., on 21st April 1997 and for all other purposes on 6th May 1997. The Waiting and Loading Restriction Order and the Restriction of Waiting on Bus Stops Order will come into operation on 6th May 1997.
9. A copy of each of the Orders, of maps indicating the location and effect of the Orders, of the Council's statement of reasons for proposing to make the Orders and of the Enfield (Waiting and Loading Restriction) (Special Parking Area) Order 1994 and the Enfield (Restriction of Waiting on Bus Stops) (Special Parking Area) (No. 1) Traffic Order 1994 (and of the Orders which have previously amended those Orders) can be inspected at the Reception Desk, "B" Block, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made.
10. Copies of the Orders may be obtained from the Traffic Engineering Group, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD.

Any person desiring to question the validity of any of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in
