Hambourg, Ödober 20. E have Letters from Stockholm of the 6th Instant, which relate, that fince the Finnish Troops were commanded to march thither from Helfingland, the Inhabitants of that Province and Gestricia agreed to form themselves into Regimente, and made choice of some of the Gentlemen of their Provinces to head them, in case the Muscovites invaded them; but as soon as the King of Sweden had Notice of it, he disapproved their Proceedings, and reprimanded the Governours sharply for suffering such Ineroachments on his Royal Authority. Embargo laid on Shipping at all the Ports of that Kingdom, is not yet extended to Gotten-burg; but by the last Letters from that Place there is little Likelyhood any Ships will very suddenly venture from thence, because if the Capers only follow them out of the Harbour, and bring them back, they will certainly be made Prize. And as to the Packet-Boats which some Persons have undertaken to provide for conveying Letters between Gottenburg and Amsterdam, we have al-ready had an Instance how little they are to be depended on; for the second that came from Amsterdam, was chased and boarded some few Leagues off Gottenburg, by a Privateer of that Place with a Danish Flag, and the Letters were thrown into the Sea. The King of Sweden quitted Swinsund on the 28th past; after he had caused the Bridge to be broken down, and a small Fort to be thrown up at that Place to prevent the Danes from laying another. The Count de la Gardie, whom the King has made a Lieutenant General, was left to command at that Pals with four Battallions of Infantry, and about 1000 Horse and Dragoons. These Lettera relate likewise, that on the 12th of September, his Swedish Majesty, without any Perfon to attend him, came to visit the Princess his Sister at Wadstena, and remained with her till next Day in the Evening: Daring his Majesty's Stay there, he was thrice in private Conversation with her Royal Highness for about two Hours each Time; and he shewed so great an Aff-ction and Tenderness for her, that it was observed he shed Tears at Parting: The Night his Majesty continued there, he lay according to his Custom on Straw, with his Clothes and Boots on, the Princels not being able to prevail with him

to make use of a Bed. On the 13th his Majesty went from Wadstena to, Lund in Schonen, and thence to Elfingbourg, accompanied by the Prince of Hesse, and a great Number of Generals and Officers; after a short Stay, they rode along the Shore to Landscrona, and thence to Malmoe, to view the Lines that have this Summer been made between those Places. The King fixed his Head Quarters at Lund, whither all the Regiments that were to compole the Swedish Army were ordered, and a Camp was marked out for them on the great Plain near that Place. His Majesty likewise ordered the Chancerie, and all the Counsellors of States to remove from Ystadt to Lund. An Order of his Swedish Majesty had been published throughout the Kingdom, requiring every whole Farm to deliver into the Provincial Magazines, Barrels of Rye (or for Want of Rye 6 Barrels of Barley) one Barrel and a half of Oats, and 800 Pounds of Hay. This Contribution amounts in some Provinces to twice as much as the Pealants whole Taxes besides for the Year. Just before the King left Swinfund, he caused Letters to be written to all the Courts of Admiralty, wherein he tells them, that notwithstanding they are still strictly to observe the Edict about Privateers, yet having thought fit to impower Baron Gottz to grant Passports to fuch Ships as he had good Affurance were not defigned for those Ports which his Majesty cannot permit any Commerce with, the Courts of Admiralty are therefore to respect the said Passes, as if the Ships were actually provided with all the Documents prescribed by the for said Edict. The Princes Royal having set out from Wadstena in order to return to Stockholm, was expected there on the 7th Instant.

Copenhagen, Oft. 17. On the 14th several of the Russian Gallies and Transports sailed from hence, but the Wind coming contrary, they were obliged to return to an Anchor again. The Czar is still here, till the Transports can sail, and then 'tis said he will go by the Way of Hanover to Holland. Yesterday an English Russner arrived here from Coningsberg: She had been 10 Days in her Passage, wherein by different Winds she made great Traverses, and altho' in Sight of Bornholm the last two Days, she neither saw nor heard any thing of the Swedish Fleet; so that 'tis hoped the

Trade will come lafely down the Baltick, the Ships from Riga being to sail as this Day; and while the Wind continues South-Easterly and keeps the Fleet here in Port, it will do the same by the Swedes. We have an Account that a Swedish Mast of War from Gottenburg of 50 Guns, has been lately lost on the Coast of Norway.

Berlin, Od. 17. The Queen of Prussia arrived here from Hanover on the 13th.

Their Prussian Majesties are now at Charlottenbourg, whither the King is retired to receive the Communion to Morrow, and will go to Brandenbourg on the 19th to review some of his Troops in those Quarters. Last Night M. Manteuffel received a Courier with Letters from Warlaw of the 9th Instant, advising that the two chief Points of the Evacuation of the Saxons, and Dissolution of the Confederacy had been figned, and the latter ratified by the Marshals of the Confederates; and that it was thought the Armistice would be renewed till the rest could be finished; but that the Islue was still uncertain, since M. Brantiski, Marshal of the Confederate Army, had paffed the River Bug on the 3d to join M. Gniasdowski, and it was thought would still endeavour to revenge the Defeat M. Gniasdowski had received on the 5th Instant from General Bosen near Kowalswo, where the Poles and Lithuanians were about 1400d Men, and the Saxons near 7000; the first lost near 4000 Men in the Action, being most of the Lithuanian Foot, with several hundred Saxons, some Deserters, and other Prisoners forced into the Service, particularly 300 of Castell's Regiment taken at Posen. A great many of them were cut to Pieces before they were known, M. Gniasdowski to prevent it baving obliged them to turn their Coats the wrong Side outwards. On the 6th General Bosen came to Thorn, and cantoned his Troops in that Neighbourhood, The King's Depatture from Warfaw had been again delayed for some Days. Mr. Whitworth, Envoy Extraordinary and Plenipotentiary of the King of Great Britain, returned bither on the 14th from Hanover. Sir Richard Vernon, His Britannick MajeRy's Envoy Extraordinary to the King of Poland, arrived here on the 14th, and set out for Gohr this Afternoon. The Countess of Cossel has been seized at Hall by the King of Prussia's Orders, but as 'tis faid at the Instances of the Court of Poland.

Hague, Off. 27. It was expected, that according to Custom the Sessions of the States of the Province of Holland would have ended on Saturday last; it seldom happening that this Assembly continues to sit after the last Day of the 2d Week! But those States re-assembled to Day, and 'tis believed will continue their Session till Saturday next. As for the extraordinary Assembly of the Deputies of the Seven Provinces, 'tis thought it will be held hext Month. Last Night the Post from the North of Germany brought Advice, that by Expresses 'twas known the Town and Castle of Temeswaer were surrendred to the Imperialists at Discretion on the 12th Instant, 'Tis adviced from Paris, that the Pietender is very ill at Avignon.

Westminster, Off. 16. This Day the Partiament met, and was further Prorogued to the 20th of November next.
