HIGHWAYS ACT 1980

The A487 Trunk Road (Bus Stop Lay-Bys, North of Caernarfon, Gwynedd) (Restriction of Waiting) Order 1997

Notice is hereby given that on 27th August 1997, the Secretary of State made the above Order which will come into operation on 1st September 1997. The effect is as stated in notice 743 in The London Gazette issue No. 54817 dated 26th June 1997.

Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers of the relevant section of the Act or that any requirement of the Act or any Instrument made under it has not been complied with, may, within 6 weeks of 29th August 1997, apply to the High Court for this purpose.

ROAD TRAFFIC REGULATION ACT 1984

The A465 Trunk Road (Merthyr Tydfil, Merthyr Tydfil County Borough) (Prescribed Route and Prohibition of Right Hand Turn) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984. The effect of the proposed Order will be to prohibit any vehicle entering the A465 Neath-Abergavenny Trunk Road at Merthyr Tydfil in the county Borough of Merthy Tydfil (hereinafter referred to as "the trunk road), via the eastbound trunk road entry slip road from the Pant Industrial Estate from proceeding in any direction other than eastwards; and proceeding in an easterly

direction in the trunk road from making right hand turns into the westbound trunk road exit slip road leading to Rocky Road.
