#### LONDON BOROUGH OF LAMBETH

#### London Borough of Lambeth Continuation of Bus Stop Clearways and Waiting and Loading Restrictions in Knight's Hill, Norwood Road, Norwood High Street, Ernest Avenue, Waterloo Road and Adjoining Streets.

(b) so that loading or unloading a vehicle will continue to be prohibited:

(i) between 7 a.m. and 7 p.m. on Mondays to Saturdays in the lengths of streets numbered 1, 6, 11, 13, 14 and 16 in Schedule 1 to this notice and in the lengths of streets specified in Schedule 3 to this notice;

(ii) between 7 a.m. and 10 a.m. and between 4 p.m. and 7 p.m. on Mondays to Fridays in the lengths of streets specified in Schedule 4 to this notice;

- (c) so that waiting by vehicles (and loading or unloading a vehicle) will continue to be prohibited at any time in both the east to west arms of Waylett Place;
- (d) so as to revoke the existing restrictions on waiting by vehicles on certain bus stops in Knight's Hill, Norwood High Street and Norwood Road, imposed by the Lambeth (Restriction of Waiting on Bus Stops) (No. 1) Traffic Order 1974:
