#### **ROAD TRAFFIC REGULATION ACT 1984**

The A494 Trunk Road (Rhydymain, Gwynedd) (Temporary 30 m.p.h. Speed Limit) Order 199

Notice is hereby given that the Secretary of State for Wales intends, in not less than 21 days from the date of this notice, to make an Order under section 14 of the Road Traffic Regulation Act 1984.

The proposed Order is necessary to reduce traffic speeds throughout the duration of the Drws-y-Nant Improvement Works on the A494 Dolgellau—South of Birkenhead Trunk Road (hereinafter referred to as "the trunk road").

The effect of the proposed Order will be to temporarily impose a 30 m.p.h. speed limit along that length of the trunk road at Rhydymain in the County of Gwynedd, which extends from a point 200 metres north-east of the centrepoint of the access to Henfaes, Rhydymain, to a point 170 metres south-west of its junction with the minor road leading to Dolddeuli.

It is expected that the restriction, the extent of which will vary as necessary, will come into force at 8 a.m., on 17th November 1997, and remain in operation until the works are completed, which is expected to be May 1999.
