The A483 Trunk Road (Welshpool Bypass, Welshpool, Powys)
(Prohibition of U-turns) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic

Regulation Act 1984.

The effect of the proposed Order will be to prohibit any vehicle proceeding northwards or southwards, on that length of the A483 Swansea-Manchester Trunk Road (hereinafter referred to as "the trunk road") known as the Welshpool Bypass at Welshpool, in the county of Powys, which extends from a point 30 metres east of its junction with the A458 Trunk Road (Berriew Road) for a distance of 2,500 metres up to, but not including the roundabout known as Old Station Roundabout, from making a U-turn.

The A483 and A458 Trunk Roads (Sarn-y-Bryn Caled Junction, Welshpool Bypass, Welshpool, Powys) (40 m.p.h. Speed Limit) Order 199.

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 84 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit the driving of motor vehicles at a speed exceeding 40 m.p.h. in that length of:

(i) the A483 Swansea to Manchester Trunk Road at Sarn-y-Bryn Caled Junction, Welshpool Bypass, Welshpool in the county of Powys, which extends from a point 160 metres north-east of its junction with the A490 to a point 205 metres south-west of its junction with the A490 for a distance of 365 metres;

(ii) the A458 Shrewsbury to Dolgellau Trunk Road at Sarn-y-Bryn Caled Junction, Welshpool Bypass, Welshpool in the county of Powys, which extends from its junction with the A483 trunk road, in a northerly direction for a distance of 155 metres.
