The Direction transposes Articles 3 and 5 to 12 (other than Articles 5(2), 6(4)(second paragraph), 8(3) and 11(1)(last paragraph)) of Directive 94/67/EC on the incineration of hazardous waste by directing the Environment Agency to include conditions to give effect to these provisions in integrated pollution control authorisations granted under section 6 of the 1990 Act which authorise the incineration of hazardous waste.

For authorisations granted on or after 31st January 1998, the conditions must be included in authorisations when granted; for authorisations granted on or after 31st December 1996 and before 31st January 1998, the conditions must be included in authorisations by 31st March 1998; and for authorisations granted before 31st December 1996, the conditions must be included in authorisations by 30th June 2000.
