*The A64 Trunk Road (Colton) (Prohibition of Use of Gaps in
Central Reservation) Order*

The Secretary of State for the Environment, Transport and the Regions, hereby gives notice that he proposes to make an Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, the effect of which will be to close two gaps in the central reservation of the A64 trunk road between Tadcaster and York as follows

- (a) the gap opposite Colton Lane End, and
- (b) the gap known as Robinsons Gap opposite the exit from the garage known as Robinsons of Colton
