ROAD TRAFFIC REGULATION ACT 1984

The Trunk Road (A55) (Waen Gate, Rhualt, Clwyd) (Closure of Central Reservation Crossings) Order 1992 (Revocation) Order 1998

Notice is hereby given that the Secretary of State for Wales has made an Order, under sections 1 and 124 of the Road Traffic Regulation Act 1984, which will come into operation on 29th October 1998

The effect of the Order will be to revoke the Trunk Road (A55) (Waen Gate, Rhualt, Clwyd) (Closure of Central Reservation Crossings) Order 1992, which is no longer required following the Pont Dafydd to Waen Improvement Scheme

A copy of the Order and the Order being revoked, together with a plan, may be inspected, free of charge, during normal opening hours (9 30 a m to 1 p m, 2 p m to 5 30 p m Mondays to Fridays, and 9 a m to 12 30 p m Saturdays) at St Asaph Post Office, during a period of 6 weeks from 29th October 1998, or may be obtained, free of charge, from the Welsh Office Highways Directorate, Roads Administration Division, Cathays Park, Cardiff CF1 3NQ, quoting Ref ZC510-2-15-2

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds

- (a) that is not within the powers of the Road Traffic Regulation Act 1984, or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may, within 6 weeks of 29th October 1998, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein
