Notice is hereby given that Elmbridge Borough Council propose to make the above-mentioned Orders, under sections 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, effecting the system of parking controls in the area of Halfway, Walton-on-Thames The general effect of the Orders will be

(a) Halfway Public Car Park To introduce within the off-street public car park at the Halfway, Walton car parking charges between the hours of 9 a m and 6 p m Monday to Friday, such charges to be set at 10p per hour for up to 4 hours parking (no return within one hour) Contract parking at £56 25 per quarter or £200 per annum with a maximum number of 15 season tickets issued

(b) The existing Controlled Parking Zone covering Walton Station area and surrounding roads be extended to cover the Halfway area The existing "Waiting Limited to I Hour" restriction in Hersham Road (which at present extends from outside No 95 to outside No 139) be amended to Monday to Friday 9 a m to 6 p m, one hour free parking A copy of the proposed Orders and a statement of the Council's reasons for making the Orders may be examined at the Civic Centre, High Street, Esher, between 9 a m and 4 30 p.m on Mondays to Fridays

A48 TRUNK ROAD, AYLBURTON, GLOUCESTERSHIRE **EXTENSION OF 30 MPH SPEED LIMIT**

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he proposes to make an Order under sections 82(2), 83(1) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A48 Trunk Road at Aylburton in the district of the Forest of Dean, in the county of Gloucestershire

The effect of the Order would be to extend the existing speed limit at Aylburton in an easterly direction by imposing a 30 mph speed limit on a length of the A48 trunk road from a point 130 metres east of its junction with Millbrook Green to a point 210 metres east of that junction, a distance of 80 metres. The existing De-restriction Order would be varied accordingly

THE A1041 TRUNK ROAD (CAMBLESFORTH) (40 MILES PER HOUR SPEED LIMIT)

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he proposes to make an Order under sections 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984

The effect of the Order will be to extend the current 40 mph speed limit on the A1041 through Camblesforth, northwards from a point 508 metres north-west of Brigg Lane, where it currently ends, to a point 40 metres north of Chestercourt Lane, a distance of approximately 520 metres

THE A1041 TRUNK ROAD (CARLTON) (PROHIBITION OF WAITING) ORDER

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he intends to make an Order under sections 1(1), 2(1) and (2), and 4(1) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984

The effect of the Order will be to prohibit waiting by vehicles at any time on any day on both sides of the A1041 trunk road, known as High Street, at Carlton, in the district of Selby, from a point 25 metres south of Hepworth Lane to a point 25 metres north of Town End Avenue

Exceptions will be provided in the Order to enable a vehicle to wait in a layby, while passengers board or alight from a vehicle (including any local bus service), while goods are loaded on or unloaded from that vehicle, in connection with any building operation or demolition, for the removal of any obstruction to traffic, for the maintenance of the road or the services therein, for fire brigade, ambulance or police purposes, for the delivery of postal packets, so that a local authority or water company can carry out its statutory duties or pursue its statutory powers, while any gate or barrier at the entrance to the premises to which the vehicle requires access, or from which it has emerged is being opened or closed, for a period not exceeding 3 hours when displaying a disabled person's parking disk, or in connection with any function being carried out at a church, or when the person in control of the vehicle is required to wait by law, in order to avoid an accident, or due to circumstances outside the person's control.
