The Secretary of State for the Environment, Transport and the Regions, hereby gives notice that he proposes to make an Order under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984, on the A259 Trunk Road in the district of Rother in the county of East Sussex.

The effect of the Order would be to impose a 40 m.p.h. speed limit on a length of the A259 at Icklesham, from a point 183 metres west of the centre-line of its junction with Broad Street, to a point 98 metres west of the centre-line of its junction with Watermill Lane (the existing 30 m.p.h. boundary), a total distance of approximately 0.64 kilometres.

**London Borough of Lambeth****THE LONDON BOROUGH OF LAMBETH (PROHIBITION OF STOPPING OUTSIDE SCHOOLS) (AMENDMENT NO. 1) ORDER 1999**

Notice is hereby given that the Council of the London Borough of Lambeth, on 10th June 1999, made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
