NOTICE OF THE ISSUE OF A SUBMARINE PIPE-LINE WORKS AUTHORISATION

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by BP Amoco, whose registered address is Britanic House, 1 Finsbury Circus, London EC2M 7BA, for the construction of a 168.3 millimetre Gas Production Pile-Line and 25.4 millimetre MEG Pipe-Line between N.W. Bell Wellhead, Manifold and Bessemer Platform.

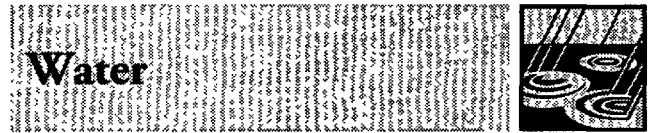
Except with the consent of the Secretary of State, the 168.3 millimetre pipe-line shall only be used to convey Natural Gas and the 25.4 millimetre pipelines shall only be used to convey Monoethylene Glycol. The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

BP Amoco has been appointed operator of the pipe-lines.

NOTICE OF APPLICATION TO VARY A LICENCE TO ABSTRACT WATER

Take Notice that Stonevine Ltd, of Chazey Heath, Mapledurham, Reading RG4 7UD, is applying to the Environment Agency to vary licence serial number 28/39/23/174 which authorises the abstraction of water from Chalk Aquifer at National Grid Reference SU6953 7725 at Mapledurham Golf Club, Chazey Heath, Mapledurham, Reading. The variation being applied for is to increase the authorised rates of abstraction from 2.73³ to 6.8M³/hour, 63.64³ to 163.20M³/day, and 8920M³ to 23000M³/year. The abstracted water will be used for spray irrigation of a Golf Course during the months April to October inclusive.
