





# AMENDMENT OF THE HOUNSLOW WEST PARKING SCHEME

### PROVISION OF DISABLED PERSONS PARKING PLACES



#### BLOCK 204/28

Pursuant to Regulation 9 (7) of the above Regulations, the Secretary of State for Trade and Industry gives notice that, being content that the requirements of the above Regulations have been satisfied, he has pursuant to Licence P903, granted consent to BP Amoco to the drilling of an exploration well in Block 204/28 (hereafter referred to as "the project") subject to BP Amoco conducting operations in respect of the project in accordance with the relevant environmental statement.

Block 204/28 lies 160 km from the Shetlands Islands, 240 km from the Faeroes.

The Secretary of State is of the view, having regard to the environmental statement prepared in respect to the project and the comments received from those consulted, that the project is not likely to have a significant effect on the environment. In coming to this view, the Secretary of State has taken into account advice received from a number of independent expert sources including the Joint Nature Conservation Committee and the Scottish Fisheries Research Services.

The Secretary of State has considered, among other matters:

the potential effects of the project on Lophelia pertusa, a marine coral known to inhibit the seas to the west of Scotland; the rate of

recolonisation of drill cuttings piles; quality of description of the seabed environment; the risk of significant environmental effects from oil spills and well test flaring.

Having taken the advice of the organisations listed earlier, the Secretary of State considers that:

any cuttings resulting from the project and likely to reach Lophelia pertusa accumulations would be so dispersed as to have no significant smothering effect on the coral. Lophelia pertusa is found in areas of relatively high current speeds and is essentially "self cleaning". The routine occurrence of "submarine storms" results in the exposure of the coral to large amounts of inorganic material in its natural state. It is therefore highly unlikely that the minimal additional amounts of input which might result from the project over a relatively short time period (2-3 months) would have a significant effect. In addition, all of the chemicals to be used in the project will have been tested for toxicity to OSPAR agreed standards; there is a large quantity of published material which documents the rate of recovery of seabed communities in similar depths in the North Sea from water based mud and cuttings piles. In addition the current regime in this area will disperse cuttings to a greater extent than in the North Sea, thus speeding up recolonisation. the seabed sampling regime adopted by BP Amoco took account of the

the seabed sampling regime adopted by BP Amoco took account of the effects of currents at the site and provided an appropriate description of the local environment; there is a only a very small risk of significant oil spill from the drilling of an exploration well. BP Amoco will be required to have an effective oil spill response plan in place prior to drilling commencing. Well test flaring using modern equipment can be over 99% efficient resulting in very little "drop-out" of hydrocarbon to the sea. BP Amoco have decided, in any case, not to test this well.

The Secretary of State also considers that, although the Government does not accept that the Habitats Directive (92/43EEC) extends to the UK Continental Shelf, safeguards to marine habitats and species applied in licensing this well are such as to ensure a degree of protection to the marine environment commensurate with the requirements of that Directive. The Secretary of State is of the view that his consideration of this project would not be materially altered by the requirements of the Habitats Directive if it were to apply, given that in his view the effect of the project on the environment will be both de minimis and transient.


