##### THE BEXLEY (PRESCRIBED ROUTES) (NO. 4) TRAFFIC ORDER 1999

##### THE BEXLEY (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 83) TRAFFIC ORDER 1999

Notice is hereby given that the Council of the London Borough of Bexley, on 16th August 1999, made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which will be as follows:

1. "At any time" waiting restrictions were introduced experimentally on 4th November 1998, in St. John's Road, Sidcup, on the south-east side, between the northern boundary of No. 50 Craybrooke Road and a point 11.0 metres north of that point and on the north-west side, between Nos. 18 and 20 St. John's Road and a point 28.0 metres south-west of that point.
2. On 2nd September 1998, the Council advertised proposals to introduce a Controlled Parking Zone (CPZ) in various roads within Sidcup Town Centre. Some of the proposals were revised and readvertised later and all the proposals have been approved for introduction. However, the Council decided to introduce only the proposals in Sidcup High Street (Elm Road to Church Road) and defer the rest of the proposals under section 19 of the Local Authorities' Traffic Order (Procedure) (England and Wales) Regulation 1996. The rest of the proposals may be introduced after the decisions of the Public Inquiry into the redevelopment proposals for the Town Centre are known.
3. The general effect of the Bexley (Waiting and Loading Restriction) (Amendment No. 83) Traffic Order 1999 will be to:
  - (a) continue in force permanently the waiting restrictions introduced in St. John's Road as described in 1 above; and
  - (b) introduce "At any time" waiting restrictions in Sidcup High Street as described in 2 above.
4. The general effect of the Bexley (Prescribed Routes) (No. 4) Traffic Order 1999 will be to continue to enforce permanently the closure of St. John's Road, Sidcup, between Granville Road and Craybrooke Road, to vehicular traffic, except for cycles, which was introduced experimentally on 4th November 1998.
5. ##### PROPOSED INTRODUCTION OF A SPECIAL PARKING BAY IN ENMORE ROAD AND REVOCATION OF A GOODS VEHICLE LOADING BAY IN DENMARK ROAD, WOODSIDE

Notice is hereby given that the Council of the London Borough of Croydon propose to make the Croydon (Waiting and Loading Restriction) (Amendment No. M 33) Order 1999 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

### PROPOSED REVOCATION AND INTRODUCTION OF PARKING PLACES AND INTRODUCTION OF WAITING RESTRICTIONS IN LOWER ADDISCOMBE ROAD AREA
