ROAD TRAFFIC REGULATION ACT 1984, SECTION 6

A4 TRUNK ROAD (GREAT WEST ROAD AND RIVERBANK WAY, HOUNSLOW) (PRESCRIBED ROUTES) ORDER 1999

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he proposes to make the above-named Order, the effect of which would be to prohibit traffic from:

(a) proceeding through the gap in the central reservation of the A4 Great West Road which lies between the southern traffic island and the northern traffic islands, to the north of Riverbank Way;

(b) making a "U" turn from the north-east bound carriageway of the A4 Great West Road through the gap in the central reservation situated at the south-west junction of the A4 Great West Road with the northern crescent road, north of Riverbank Way;

(c) proceeding in any direction other than straight ahead in the southwest bound carriageway of the A4 Great West Road after passing to the right of the southern traffic island adjacent to Riverbank Way;

(d) from turning right from the north-eastbound carriageway of the A4 Great West Road through the gap in the central reservation situated at the south-west junction of the A4 Great West Road with the northern crescent road, north of Riverbank Way;

(e) proceeding in any direction other than straight ahead when passing to the right of the splitter island on the south-western side of the A4 Great West Road junction with the southern crescent road, north of Riverbank Way:

(f) proceeding in any direction other than left when passing to the left of the splitter island on the south-western side of the A4 Great West Road junction with the southern crescent road, north of Riverbank Way;

(g) proceeding in any direction other than eastbound on the northern crescent road or westbound on the southern crescent road;

(h) proceeding in any direction other than left when entering the A4 Great West Road from the northern crescent road.

Statement of Reasons

In order to improve safety and also facilitate the passage of traffic at the junction of the A4 Great West Road with the northern and southern crescent roads, north of Riverbank Way, in the London Borough of Hounslow, the Secretary of State for the Environment, Transport and the Regions, proposes to make an Order, the effect of which would be to prohibit traffic from:

(a) proceeding through the gap in the central reservation of the A4 Great West Road which lies between the southern traffic island and the northern traffic islands, to the north of Riverbank Way;

(b) making a "U" turn from the north-east bound carriageway of the A4 Great West Road through the gap in the central reservation situated at the south-west junction of the A4 Great West Road with the northern crescent road, north of Riverbank Way;

(c) proceeding in any direction other than straight ahead in the southwest bound carriageway of the A4 Great West Road after passing to the right of the southern traffic island adjacent to Riverbank Way;

(d) turning right from the north-east bound carriageway of the A4 Great West Road through the gap in the central reservation situated

at the south-west junction of the A4 Great West Road with the northern crescent road, north of Riverbank Way;

(e) proceeding in any direction other than straight ahead when passing to the right of the splitter island on the south-western side of the A4 Great West Road junction with the southern crescent road, north of Riverbank Way;

(f) proceeding in any direction other than left when passing to the left of the splitter island on the south-western side of the A4 Great West Road junction with the southern crescent road, north of Riverbank Way;

(g) proceeding in any direction other than eastbound on the northern crescent road or westbound on the southern crescent road;

(h) proceeding in any direction other than left when entering the A4 Great West Road from the northern crescent road.

THE A16 TRUNK ROAD (SIBSEY, LINCOLNSHIRE) (40 MILES PER HOUR SPEED LIMIT) ORDÉR 1999

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984, on a length of the A16 Trunk Road at Sibsey in Lincolnshire.

The effect of the Order, which comes into force on 24th November 1999, will be to impose a 40 m.p.h. speed limit on the length of the A16 between points 50 metres and 856 metres south of its junction with the B1184 (Frithville Road). This will extend the length currently subject to a 40 m.p.h. speed limit by 806 metres.

THE A595 TRUNK ROAD (CEMETERY LAY-BY, EGREMONT) (PROHIBITION AND RESTRICTION OF WAITING) ORDER

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he intends to make an Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulations Act 1984.

The effect of the Order will be to restrict waiting for more than 2 hours, with no return within 2 hours between the hours of 6 a.m. and 6 p.m. on any day, Monday to Sunday, in the Cemetery lay-by situated adjacent to the A595 trunk road, at Egremont, in the county of Cumbria, from a point 250 metres north of the Jubilee Road Garage junction to a point 60 metres north of the Jubilee Road Garage junction.

Exceptions have been provided in the Order to enable a vehicle to be used in connection with any building operation or demolition; for the removal of any obstruction to traffic; for the maintenance of the road or services therein; for police, fire brigade or ambulance purposes; and by a local authority or water company in pursuance of their respective statutory powers or duties.
