The draft Order contains provisions restricting the use of the parking places to use by those classes of vehicle specified in the Schedule hereto and also specifies for such parking places their days of operation, hours of operation and scale of charges as stated in the Schedule. Car parking charges will be collected either by means of "pay and display" machines or by the parking attendants located within the car parks.

A copy of the draft Order, and the plans contained therein together with a copy of the statement of the Council's reasons for proposing to make the Order, may be inspected at the offices of the undersigned during normal office hours, or at the offices of Denbighshire Countryside Services, at Loggerheads Country Park during normal office hours.

Parking permits are available for purchase per vehicle for such charge as shall be specified by the Council valid in such parking places and subject to such conditions on the permit during the period for which it is issued.

Any person wishing to object to the proposed Order should send a written statement of objection stating the grounds on which they are made to the Director of Technical Services, Denbighshire County Council, Council Offices, Caledfryn, Smithfield Road, Denbigh, by no later than 10th March 2000.

Name of Parking Place/Car Park: Loggerheads Country Park:

Class of Vehicle: Motor Car as defined in section 136(2)(a), motor cycle as defined in section 136(4) and invalid carriage as defined in section 136(5) of the Act and motor vehicles not exceeding 30 cwt unladen weight constructed or adapted solely for the purpose of carrying goods.

Days of Operation of Parking Place: Monday to Sunday.

Hours of Operation of Parking Place when Charge is payable: 8 a.m. to 9 p.m. in the summer period (British Summer Time), 8 a.m. to 6 p.m. in winter periods (at all times other than British Summer Time).

Maximum Period for which vehicles may wait: As Hours of Operation of Parking Place when Charge is payable.

Position in which vehicle may wait: Wholly within a parking bay where such bays are marked or as directed by the parking attendant.

Scale of Charges: 20p for up to 1 hour, £1.20 for up to 4 hours, £2.50 all day. Coaches shall be exempt from the above. Holders of a valid Countryside Sites Parking Permit shall be exempt from the above.

Name of Parking Place/Car Park: Moel Famau Country Park

Class of Vehicle: Motor Car as defined in section 136(2)(a), motor cycle as defined in section 136(4) and invalid carriage as defined in section 136(5) of the Act and motor vehicles not exceeding 30 cwt unladen weight constructed or adapted solely for the purpose of carrying goods.

Days of Operation of Parking Places: Monday to Sunday.

Hours of Operation of Parking Place when Charge is payable: 8 a.m. to 9 p.m. in the summer period (British Summer Time), 8 a.m. to 6 p.m. in winter periods (at all times other than British Summer Time).

Maximum Period for which vehicles may wait: As Hours of Operation of Parking Place when Charge is payable.

Position in which vehicle may wait: In the parking place or as directed by the parking attendant.

Scale of Charges: 20p for up to 1 hour, £1.00 for up to 4 hours, £2.00 all day. Holders of a valid Countryside Sites Parking Permit shall be exempt from the above.

Name of Parking Place/Car Park: Llantysilio Green

Class of Vehicle: Motor Car as defined in section 136(2)(a), motor cycle as defined in section 136(4) and invalid carriage as defined in section 136(5) of the Act and motor vehicles not exceeding 30 cwt unladen weight constructed or adapted solely for the purpose of carrying goods.

Position in which vehicle may wait: In parking place or as directed by the parking attendant.

Scale of Charges: 50p all day but not between the hours of 12 midnight to 8 a.m.

Days of Operation of Parking Place: From Easter to end of September.

Hours of Operation of Parking Place when Charge is payable: 8 a.m. to 9 p.m. in the summer period (British Summer Time). No charge during winter period.

Maximum Period for which vehicles may wait: A 16 hour period between the hours of 8 a.m. to 12 midnight subject to hours of operation.

CANNON HILL/FORESTDALE—INTRODUCTION OF A PROHIBITED RIGHT TURN

Notice is hereby given that the Council of the London Borough of Enfield, on 11th February 2000, made the Enfield (Prescribed Routes) (No. 2) Traffic Order 2000, under section 6 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

2. The general effect of the Order will be to prohibit vehicles proceeding in the southbound carriageway of Cannon Hill on reaching the junction with Forestdale from turning right.

3. The prohibitions referred to in paragraph 2 above will not apply in relation to anything done:

(a) with the permission or at the direction of a police constable in uniform;

(b) in accordance with any prohibition, restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

4. A copy of the Order, which will come into operation on 28th February 2000, of a map indicating the location and effect of the Order and of the Council's statement of reasons for proposing to make the Order, can be inspected at the Reception Desk, "B" Block, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, during normal office hours on Mondays to Fridays inclusive, until the end of 6 weeks from the date on which the Order was made.

5. Copies of the Order may be obtained from Traffic Engineering, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD.

6. Any person desiring to question the validity of the Order or any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

NEW ROADS AND STREET WORKS ACT 1991, SECTION 58

NOTICE OF SUBSTANTIAL ROADWORKS

Three months advance notice is hereby given that Denbighshire County Council intends to carry out substantial road works.

2. The streets/roads in which these works will take place are: Warren Road, Westbourne Avenue, Wood Road, Stanmore Street and Seabank Road, at Rhyl, in the county of Denbighshire.

3. Work is expected to affect both carriageway *and* the footway in the above streets.

4. Work is expected to commence on Monday, 5th June 2000.

5. The works notified will include the following:

- Carriageway and footway resurfacing.
- Narrowing and widening of footway to accommodate parking bays.
- Installation of road humps and junction plateaux.
- Provision of new road traffic signing.

6. Subject to the exemptions in the Act and regulations under it, no street works may be executed for a period of 12 months from the completion of the works described in paragraph 5 without the consent of the said highway authority, which shall not be unreasonably withheld.
