##### NEW ROADS AND STREET WORKS ACT 1991, SECTION 58 NOTICE OF SUBSTANTIAL ROAD WORKS

Three months advance notice is hereby given that Denbighshire County Council intends to carry out substantial road works.

2. The streets and roads in which these works will take place is: Warren Road, Westbourne Avenue, Wood Road, Stanmore Street and Seabank Road at Rhyl in the county of Denbighshire.

3. Work is expected to affect both the carriageway and the footway in the above streets.

4. Work is expected to commence on Monday, 5th June 2000.

5. The works notified will include the following:

- (a) Carriageway and footway resurfacing.
- (b) Narrowing and widening of footway to accommodate parking bays.
- (c) Installation of road humps and junctions plateaux.
- (d) Provision of new road traffic signing.

6. Subject to the exemptions in the Act and regulations under it, no street works may be executed for a period of 12 months from the completion of the works described in paragraph 5 without the consent of the said Highway Authority, which shall not be unreasonably held.
