#### ALTERATION TO THE LAYOUT OF METERED PARKING AND MOTOR CYCLE PARKING IN LLOYD'S AVENUE

Schedule

The irregularly shaped area of footpath, adjacent to the northern boundary of the Mancunian Way, and the approach ramp and steps to the subway beneath the Mancunian Way to Jackson Crescent, running from a point 43 metres east of the subway in a westerly then northerly direction to its junction with Melbourne Street, for a total distance of approximately 134 metres and at widths varying between approximately 2 and 7 metres.

2. The subway approach ramp and steps on the northern side of the Mancunian Way from a point 43 metres east of the subway beneath the Mancunian Way to Jackson Crescent, running in a westerly direction for a distance of approximately 60 metres and at a width of 4 metres.

3. The subway crossing beneath the Mancunian Way 83 metres east of the Mancunian Way junction with Crown Street for a length of approximately 36.5 metres and at a width of 4 metres.

Footpath adjacent to the southern boundary of the Mancunian Way running from a point 7 metres west of the subway beneath the Mancunian Way to Jackson Crescent at its junction with the footpath which runs from the southern end of the subway, in a north westerly then westerly direction to a point 44 metres west of the subway, at its junction with the footpath which runs from Jackson Crescent in a north-westerly direction towards the Mancunian Way, for a distance of approximately 39 metres and at a width of 3 metres.
