ROAD TRAFFIC REGULATION ACT 1984

THE A50 TRUNK ROAD (BLYTHE BRIDGE TO UTTOXETER, STAFFORDSHIRE) (24 HOURS CLEARWAY) ORDER 200

The Secretary of State for the Environment, Transport and the Regions hereby gives notices that he proposes to make an Order, under sections 1(1), 2(1) and (2) and 4(1) of the Road Traffic Regulation Act 1984, on a length of the A50 Trunk Road in Staffordshire.

The effect of the Order would be to prohibit waiting at any time, other than in a layby, and to prohibit trading in laybys, on the following lengths of the trunk road and slip roads:

- (a) the eastbound carriageway from a point 135 metres west of the Blythe Bridge interchange West Bridge to a point 25 metres east of the centre point of its roundabout junction with the B5030, a distance of 17.043 metres:
- (b) the westbound carriageway from a point 25 metres east of the centre junction with the B5030 to a point 80 metres east of the Blythe Bridge Interchange East Bridge, a distance of 16,185 metres;
- (c) the eastbound entry and westbound exit slip roads at the Blythe Bridge Interchange;
- (d) the eastbound and westbound entry and exit slip roads at the Grindley Interchange;
- (e) the eastbound entry and exit slip roads to the A522 west of Uttoxeter; and
- (f) the westbound entry and exist slip roads to the A522 New Road, Uttoxeter.

THE A134 TRUNK ROAD (WHITTINGTON HILL, NORFOLK) (40 MILES PER HOUR SPEED LIMIT) ORDER 2000

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order, under sections 84(1) and (2) of the Road Traffic Regulation Act 1984, on the A134 Trunk Road at Whittington Hill in Norfolk.

The effect of the Order, which will come into force on 20th June 200, will be to impose a 40 m.p.h. speed limit on the length of trunk road between points 20 metres east and 770 metres east of its roundabout junction with the B1106, a distance of 750 metres.

PROPOSED WAITING AND LOADING RESTRICTIONS IN ROBSART STREET

Notice is hereby given that the Council of the London Borough of Lambeth propose to make the Lambeth (Waiting and Loading Restriction) (Special Parking Area) (Amendment No.) Order 2000, under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.

In brief, the general nature and effect of the Order would be to prohibit waiting by vehicles (including waiting for the purpose of loading or unloading a vehicle) at any time on the south side of Robsart Street, between a point 5.5 metres west of the eastern wall of Nos. 274 to 282 Brixton Road and its junction with the unnamed road lying on the west side of Wayland House.

The prohibition is necessary to prevent parking which obstructs the free flow of traffic and also hinders access for refuse collection vehicles and emergency services vehicles.
