THE A3 TRUNK ROAD (OCKHAM COMMON LAYBY) (WAITING RESTRICTIONS) ORDER 200

The Secretary of State for the Environment, Transport and the Regions, hereby gives notice that he proposes to make an Order, under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A3 Trunk Road in the county of Surrey.

The effect of the Order would be to prohibit vehicles other than heavy commercial vehicles (HGVs) waiting in the layby on the eastern side of the slip road leading to the southbound carriageway of the A3, northwards from its junction with Old Lane for a distance of 150 metres, at Wisley Interchange (M25—Junction 10), between 1800 and 0700 hours on any day.

THE A1 TRUNK ROAD (BIGGLESWADE NORTH TO BEESTON, BEDFORDSHIRE) (60 MILES PER HOUR SPEED LIMIT) ORDER 200

The Secretary of State for the Environment, Transport and the Regions, hereby gives notice that he proposes to make an Order, under sections 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A1 Trunk Road between Biggleswade North and Beeston in Bedfordshire.

The effect of the Order would be to impose a 60 miles per hour speed limit on the length of the A1 between points 10 metres north of the Biggleswade North Roundabout and 155 metres south-east of its junction with New Road, Sandy, a distance of 2,750 metres, and to vary The A1 and A428 Trunk Roads (Bedfordshire) (De-Restriction) Order 1994.

THE A6 TRUNK ROAD (SHARNBROOK, BEDFORDSHIRE) (DERESTRICTION) ORDER 200

The Secretary of State for the Environment, Transport and the Regions, hereby gives notice that he proposes to make an Order, under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984, on the A6 Trunk Road at Sharnbrook in Bedfordshire.

The effect of the Order would be to remove the 30 miles per hour speed limit automatically imposed by the installation of street lighting between points 75 metres north and 75 metres south of the newly constructed roundabout on the A6 at its junction with the C26 (Mill Road), and restore the national speed limit of 60 miles per hour.

GROVE AREA CONTROLLED PARKING ZONE

Notice is hereby given that, the Council of the Royal Borough of Kingston-upon-Thames, on 21st July 2000, made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of the Road Traffic Regulation Act 1984 (as amended).

The general effect of the Orders would be:

(a) to modify the Kingston controlled parking zone so that the following streets, or parts of streets will be removed from that zone and incorporated within the proposed Grove Area controlled parking zone—Denmark Road, Grove Crescent, Mill Place, north to south arm, Penryhn Road, from its junction with Wheatfield Way, and Kingston Hall Road to the north-eastern kerb-line of the south-western arm of Grove Crescent, Portland Road, Springfield Road, Villiers Road and Watersplash Close;

(b) to introduce a controlled parking zone in the Grove Area which would operate between the hours of 8.30 a.m. to 6.30 p.m., on Monday to Friday inclusive, in Zone G and between 8.30 a.m. and 6.30 p.m., on Mondays to Saturdays inclusive, in Zone G1;
