The general effect of the Bexley (Waiting and Loading Restriction) ) Traffic Order 200X, would be to amend the Bexley (Amendment No. (Waiting and Loading Restriction) Order 1991 so that 8 a.m. to 6.30 p.m. Monday to Saturday waiting restrictions would apply in parts of Upton Road, and "At any time" waiting restrictions in the roads listed in the Schedule to this notice.
