### Road Traffic Acts

#### London Borough of Newham

##### CANNING TOWN CONTROLLED PARKING ZONE

Notice is hereby given that the Council of the London Borough of Newham, on 8th January 2001, made the Newham (Canning Town) (Parking Places) (Special Parking Area) (No. 1) Order 2001, and the Newham (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 54) Order 2001, under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, and the Road Traffic Act 1991.

The general effect of the Orders will be to introduce a system of controlled parking which will operate between 10 a.m. and 4 p.m. on Monday to Friday in Clarkson Road, Rathbone Street and Wouldham Road.

The Parking Places Order will provide for parking places in Clarkson Road, Rathbone Street and Wouldham Road for use in connection with the parking of vehicles by:

- (i) resident permit holders of the controlled parking zone (including the roads shown at note (iv) below (permits valid for 12 months will cost £15 for the first vehicle in any one household; a permit for a second vehicle will cost £30 and thereafter £50 per vehicle—permits will also be available for 3 and 6 months at pro rata charges);
- (ii) residents' visitor permit holders, at a rate of 30 pence for 6 hours by use of cards, initially with a total value of £3;
- (iii) business permit holders (for essential users only), at a cost of £200 for 12 months—permits will also be available for 3 and 6 months at pro rata charges;
- (iv) casual business permit holders, at a cost of £2 per day (maximum period of use will be 5 days at a time);
- (v) discretionary residents' visitor permit holders (issued in exceptional circumstances at the discretion of the Council);

##### NOTES:

- (i) only passenger vehicles (12 seats or less) and goods carrying vehicles (the overall height and length of which does not exceed 2.3 metres and 5.3 metres respectively), and invalid carriages, displaying a valid permit as described above, may be left in the parking places;
- (ii) certain vehicles may wait in the parking places free of charge in certain circumstances (e.g. to allow persons to board or alight

(maximum 2 minutes) or to load or unload goods (maximum 20 minutes);

(iii) motor-cycles and pedal cycles will be allowed to park free of charge in the parking places;

(iv) occupiers of premises in Chedworth Close, Sabbarton Street and that length of Silvertown Way which lies between Canning Town Roundabout and Sabbarton Street will be eligible to purchase permits for use in Clarkson Road, Rathbone Street and Wouldham Road.

The Waiting and Loading Restriction Order will provide that waiting restrictions will operate:

(a) "at any time" (double yellow lines) around corners in Clarkson Road, Rathbone Street and Wouldham Road; and

(b) between 10 a.m. and 4 p.m. on Monday to Friday inclusive (single yellow lines) (except within parking places) in the remaining lengths of Clarkson Road, Rathbone Street and Wouldham Road.

Copies of the Orders, which will come into force on 26th February 2001, and of documents giving more detailed particulars of the Orders, can be inspected, until the end of 6 weeks from the date on which the Orders were made, during normal office hours on Mondays to Fridays inclusive, at the offices of the Director of Environment, 25 Nelson Street, East Ham, London E6 6EH, from whom copies of the Orders may be obtained.

If any person wishes to question the validity of either of the Orders or of any provision on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any requirement of the Act or of any Instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the Orders were made, apply for the purpose to the High Court.

#### LITTLE ILFORD RESIDENTIAL HAVEN

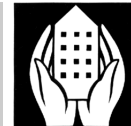

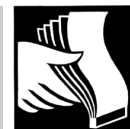

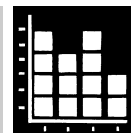
