NOTICE OF SUBSTANTIAL ROAD WORKS (ENGLAND AND WALES)

NOTICE OF SUBSTANTIAL WORKS FOR ROAD PURPOSES (SCOTLAND)

Three months advance notice is hereby given that the London Borough of Ealing Highway Authority intends to carry out substantial road works (England and Wales)/substantial works for road purposes (Scotland).

2. The roads in which these works will take place are listed below:

3. Work will affect the carriageway as described, between the locations as listed above.

4. Work is expected to commence on 1st May 2001 or within one month of this date.

5. The work notified will include the following:

- (a) Some partial reconstruction.
- (b) Relaying some kerbs and pavings of the footways.

6. Subject to the exemptions in the Act and regulations under it, no street works may be executed for a period of 12 months from completion of the works described in paragraph 5, without the consent of the said Highway Authority, which shall not be unreasonably withheld.
