Highways Agency ROAD TRAFFIC REGULATION ACT 1984 THE A523 TRUNK ROAD (MACCLESFIELD RELIEF ROAD) (DE-RESTRICTION) ORDER 1993 VARIATION ORDER 200

The Secretary of State for Transport, Local Government and the Regions hereby gives notice that he intends to make an Order, under section 82(2) and 83(1) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A523 Trunk Road, known as Macclesfield Relief Road, in Macclesfield in the county of Cheshire.

The effect of the Order would be to vary the A523 Trunk Road (Macclesfield Relief Road) (De-Restriction) Order 1993 by extending the existing 30 m.p.h. speed limit on A523 southbound carriageway, by an additional 43 metres, on its approach to its roundabout junction with Hulley Road.

#### ROAD TRAFFIC REGULATION ACT 1984 THE A523 TRUNK ROAD (POYNTON (SOUTH), CHESHIRE) (40 M.P.H. SPEED LIMIT) ORDER 200

The Secretary of State for Transport, Local Government and the Regions hereby gives notice that he intends to make an Order, under sections 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A523 Trunk Road at Poynton in the county of Cheshire.

The effect of the Order would be to impose a 40 m.p.h. speed limit on the A523 Trunk Road from a point 182 metres south of its junction with Street Lane to a point 64 metres north of its junction with Hope Green Way. The Order would revoke the Trunk Roads (40 m.p.h. Speed Limit) (No. 19) Order 1981.

By revoking the above Order a short length of the A523 Trunk Road from a point 64 metres north of its junction with Hope Green Way to its junction with Lostock Road would revert to a 30 m.p.h. speed limit by virtue of the street lighting installed on it.

THE BEXLEY (WAITING AND LOADING RESTRICTION) (AMENDMENT NO.) TRAFFIC ORDER 200. THE BEXLEY BUS STOP CLEARWAY (NO STOPPING EXCEPT BUSES) (AMENDMENT NO.) TRAFFIC ORDER 200.

THE BEXLEY (WELLING STATION AREA) (PARKING PLACES) (AMENDMENT NO.) TRAFFIC ORDER 200.

Notice is hereby given that the Council of the London Borough of Bexley propose to make the above-mentioned Traffic Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by section 8 of, and Part 1 of Schedule 9 to, the Local Government Act 1985.

The Bexley (Waiting and Loading Restriction) (Amendment No. ) Traffic Order 200 would:

(a) introduce "At any time" waiting restrictions in parts of Burnt Oak Lane; Collindale Avenue, Sidcup; Dryden Road; Edison Road; Maple Crescent; Sidcup Hill; Sussex Road; and Wellington Avenue;

(b) introduce 8 a.m. to 7 p.m. Monday to Saturday waiting restrictions in parts of Oxford Road; and Sidcup Hill;

The Bexley Bus Stop Clearway (No Stopping Except Buses) (Amendment No. ) Traffic Order 200 would introduce "At any time" bus stop clearway restrictions at the bus stops in Cray Road; Sidcup Hill; Sidcup High Street; Station Road, Sidcup; Halfway Street; Willersley Avenue; The Oval; Wellington Avenue; Westwood Lane; Hook Lane; Central Avenue; Vaughan Road; Wickham Street and Edison Road.

The Bexley (Welling Station Area) (Parking Places) (Amendment No. ) Traffic Order 200 would amend the Bexley (Parking Places) (No. 1) Traffic Order 1995 so that the short stay parking places on the west side of Central Avenue are resited to enable the bus stop marking to be extended.
