#### Highways Agency ROAD TRAFFIC REGULATION ACT 1984 A417 TRUNK ROAD (BIRDLIP HILL) (PROHIBITION OF RIGHT TURN) ORDER 2001

The Secretary of State for Transport, Local Government and the Regions, hereby gives notice that he made this Order on 23 July 2001, coming into force on 27 July 2001, on the A417 Trunk Road at Birdlip Hill near the Air Balloon Roundabout, in the district of Cotswold in the county of Gloucestershire. The notice of the proposal to make it, HA 41/29/90 was published in issue No. 56096 of The London Gazette on 22 January 2001 and the effect of the Order is as described in that notice. ### *London Borough of Bexley* THE BEXLEY (PROHIBITION OF STOPPING OUTSIDE SCHOOLS) (AMENDMENT NO. ) TRAFFIC ORDER 200
