HEATHROW AIRPORT LIMITED (40 MPH SPEED LIMIT) (AMENDMENT NO 1) ORDER 2002

SPEED RESTRICTION CHANGE—WESTERN PERIMETER ROAD

Notice is hereby given that Heathrow Airport Limited (being a wholly owned subsidiary of BAA plc), proposes to make an Order under sections 84(1) and (2) and Schedule 9 to the Road Traffic Regulation Act 1984, having effect by virtue of sections 1, 2 and 65 of the Airports Act 1986.

The general nature of this Order is to enforce a 30 mph speed restriction on the Western Perimeter Road for a distance of 1.54 miles (2,482 metres) to its junction with the Southern Perimeter Road.

A copy of the draft Order, a plan illustrating the proposals and a statement of reasons may be inspected between 9.00 am and 4.00 pm, Monday to Friday, at the offices of the General Manager, Ground Operations, Heathrow Airport Limited, Europa Suite, Terminal 2, Heathrow Airport, Middlesex UB3 5AP.

THE BARNET (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (1997, NO 53) (AMENDMENT NO 39) TRAFFIC ORDER 2002

Notice is hereby given, that the Council of the London Borough of Barnet have made on 13 February 2002 an Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

This Order amends existing waiting and loading restrictions and introduces new waiting and loading restrictions in various roads as shown in the schedules below. These waiting restrictions will ensure the free passage of vehicles, protects vehicle accesses and maintain junction safety.

Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the relevant powers of the Road Traffic Regulations Act 1984 or that any of the relevant requirements thereof or of any regulations made thereunder have not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

north-east side:

- (i) from its junction with Hale Lane north-westwards for a distance of 17 metres
- (ii) from a point 17 metres north-west of its junction with Hale Lane to a point 11 metres north-west of a point opposite the common boundary of Nos 22 and 24 Broadfields Avenue

Deansbrook Road:

- (a) both sides:
- (i) from its junction with Burnt Oak Broadway north-eastwards for a distance of 19 metres
- (b) north-west and north side:
- (i) from a point 19 metres north-east of its junction with Burnt Oak Broadway north-eastwards to a point 24 metres north-east of a point opposite the northeastern kerbline of Heming Road
- (c) south-east and south side:
- (i) from a point 19 metres north-east of its junction with Burnt Oak Broadway to a point 1 metre north-east of a point in line with the south-western kerbline of Heming Road
- (ii) from a point 1 metre north-east of a point in line with the south-western kerbline of Heming Road northeastwards for a distance of 25 metres
- (iii) from a point 26 metres north-east of a point in line with the south-western kerbline of Heming Road northeastwards for a distance of 4 metres
- (iv) from a point opposite the common boundary of Nos 209 and 211 Deansbrook Road to a point opposite the common boundary of Nos 276 and 278 Deansbrook Road
