THE LONDON BOROUGH OF SOUTHWARK (FREE PARKING PLACES) (DISABLED PERSONS) TRAFFIC ORDER 2002/007

NOTICE OF TRAFFIC MANAGEMENT ORDER

1. Notice is hereby given that the Council of the London Borough of Southwark on 5 March 2002, made the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1984.

2. The general effect of the Order will be to designate disabled persons parking places in the lengths of roads specified in the Schedule to this notice in which vehicles displaying a disabled persons badge may be left in any period during the permitted hours without charge.

3. 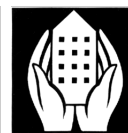

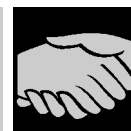

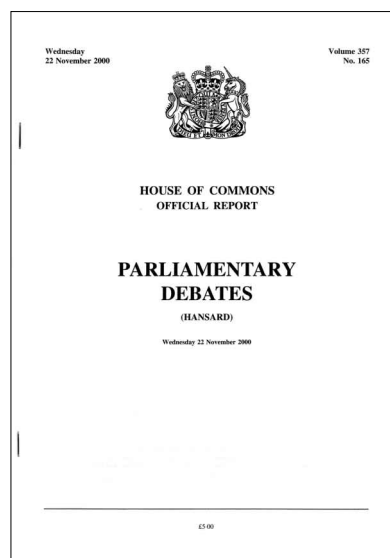
