## Royal Warrant

17 September 2002

### THE DISTINGUISHED SERVICE CROSS

*ELIZABETH THE SECOND*, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland, and of Her other Realms and Territories Queen, Head of the Commonwealth, Defender of the Faith, to all to whom these Presents shall come:

#### GREETING!

WHEREAS His late Majesty King Edward VII did, by Order in Council dated 15th June 1901 institute a Decoration to be called the Conspicuous Service Cross;

AND WHEREAS His late Majesty King George V did sanction, by Order in Council dated 14th October 1914, the said Cross to be in future designated the Distinguished Service Cross: and, by Order in Council dated 19th May 1931, did amend and consolidate the regulations governing the said Cross;

AND WHEREAS His late Majesty King George VI, by Orders in Council dated 20th December 1939, 17th April 1940, 5th November 1942 and 13th January 1943, and We, by Order in Council dated 13th October 1980, did further amend the regulations governing eligibility for the Distinguished Service Cross;

AND WHEREAS We deem it expedient to amend the regulations further to allow members of any rank in all Our Armed Forces to receive the said Cross;

NOW THEREFORE, We do hereby declare that the regulations promulgated by the aforementioned Orders in Council in respect of the Distinguished Service Cross shall be abrogated, cancelled and annulled; and in substitution thereof We, by these Presents for Us, Our Heirs and Successors, are graciously pleased to make, ordain and establish the following rules and ordinances, which shall from henceforth be inviolably observed and kept.

*Firstly:* It is ordained that the Decoration shall be designated and styled the "Distinguished Service Cross".

*Secondly:* It is ordained that the Decoration shall consist of a Cross having on the obverse in the centre the Royal Cypher surmounted by the Crown, that the reverse shall be plain and bear the rank, name and Service, Regiment or Corps customarily appropriate to the recipient, and the date of award; that the Cross shall be suspended by a ring, and that the whole shall be in silver.

*Thirdly:* It is ordained that the Distinguished Service Cross shall be worn on the left breast suspended on a ribbon one-and-three-eighths inches in width with equal stripes of dark blue, white and dark blue.

It is further ordained that in the official list showing the order in which Orders, Decorations and Medals are to be worn it shall be placed immediately after the Royal Red Cross, First Class.

*Fourthly:* It is ordained that the Distinguished Service Cross shall be awarded in recognition of an act or acts of exemplary gallantry during active operations against the enemy at sea. It may be awarded to members, of any rank, of:

- (a) Our Naval, Military and Air Forces; or
- (b) Our Royal Fleet Auxiliary Service; or
- (c) the Merchant Navy

on the recommendation of Our Secretary of State for Defence or of the appropriate Minister of State for the other Realms and Territories of which We are Queen.

It is further ordained that members, of any rank, of a Foreign Naval, Military or Air Force or those of Commonwealth States of which We are not Queen who have been associated with operations of Our Naval, Military and Air Forces shall be eligible for the award of the Distinguished Service Cross on the recommendation of Our Secretary of State for Defence with the agreement of the appropriate Minister of State of the said Foreign country or Commonwealth State.

*Fifthly:* It is ordained that the Decoration may be awarded posthumously.

*Sixthly:* It is ordained that in the event of a person who has been awarded the Decoration again performing such an act or acts as would have entitled him or her to the Distinguished Service Cross if he or she had not already received it, such further act or acts shall be recorded by a Bar attached to the ribbon by which the Decoration is suspended and for every further act an additional Bar shall be added. A rose Emblem denoting the award of each Bar shall be worn on the ribbon when the ribbon only is worn.

*Seventhly:* It is ordained that the Distinguished Service Cross shall not confer any individual precedence but shall entitle the recipient to the addition after his or her name of the letters "DSC".

*Eighthly:* It is ordained that the names of those upon whom We may be pleased to confer this Decoration shall be published in the *London Gazette*, and that a Register thereof shall be kept in the office of Our Secretary of State for Defence.

*Ninthly:* It is ordained that reproductions of the Distinguished Service Cross and Bar, known as a Miniature Cross, which may be worn on certain occasions by those to whom the Decoration is awarded, shall be half the size of the Distinguished Service Cross and Bar respectively and that a sealed pattern of the said Miniature shall be kept in the Central Chancery of Our Orders of Knighthood.

*Tenthly:* It is ordained that it shall be competent for Us, Our Heirs and Successors, by an Order under Our Sign Manual and on the recommendation of Our Secretary of State for Defence to cancel and annul the award of the Distinguished Service Cross to any person and that thereupon his or her name shall be removed from the aforementioned Register: but that it shall be competent for Us, Our Heirs and Successors, to restore the Decoration when such recommendation has been withdrawn.

It is further ordained that notice of cancellation or restoration in every case shall be published in the *London Gazette*.

*Lastly:* We reserve to Ourselves, Our Heirs and Successors, full power of annulling, altering, abrogating, augmenting, interpreting or dispensing with these rules and ordinances, or any part thereof, by a notification under Our Sign Manual.

*Given at Our Court of St James's this Twenty-ninth day of July, Two Thousand and Two, in the Fifty-first Year of Our Reign.*

## THE MILITARY CROSS

*ELIZABETH THE SECOND*, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland, and of Her other Realms and Territories Queen, Head of the Commonwealth, Defender of the Faith, to all to whom these Presents shall come:

## GREETING!

WHEREAS His late Majesty King George V did, by a Warrant under His Sign Manual dated 28th December 1914, institute a Decoration to be called the Military Cross; and by Warrants under Sign Manual dated 23rd August 1916, 25th June 1917, 6th November 1920 and 5th February 1931 did amend and consolidate the regulations governing the said Decoration;

AND WHEREAS His late Majesty King George VI, by Warrants under His Sign Manual dated 21st August 1939 and 14th April 1943, and We, by Warrants under Our Sign Manual dated 24th September 1953 and 1st August 1980, did further amend the regulations governing eligibility for the Military Cross;

AND WHEREAS We deem it expedient to amend the regulations further to allow members of any rank in Our Armed Forces to receive the said Cross;

NOW, THEREFORE, We do declare that the regulations promulgated in the aforementioned Warrants in respect of the Military Cross shall be abrogated, cancelled and annulled; and in substitution thereof We by these Presents for Us, Our Heirs and Successors, are graciously pleased to make, ordain and establish the following rules and ordinances, which shall from henceforth be inviolably observed and kept.

*Firstly:* It is ordained that the Decoration shall be designated and styled "The Military Cross".

*Secondly:* It is ordained that the Decoration shall consist of a Cross having on each arm the Imperial Crown and bearing in the centre the Royal Cypher; that the reverse of the Cross shall be plain and bear the rank, name and Service, Regiment or Corps, customarily appropriate to the recipient and the date of award; that the Cross shall be suspended by a ring from a bar; and that the whole shall be in silver.

*Thirdly:* It is ordained that the Decoration shall be worn on the left breast suspended on a watered ribbon one-and-a-quarter inches in width of white with a purple stripe.

It is further ordained that in the official list showing the order in which Orders, Decorations and Medals are to be worn it shall be placed immediately after the Distinguished Service Cross.

*Fourthly:* It is ordained that the Decoration shall be awarded in recognition of an act or acts of exemplary gallantry during active operations against the enemy on land to all members, of any rank, of Our Naval, Military and Air Forces on the recommendation of Our Secretary of State for Defence or the appropriate Minister of State of the other Realms and Territories of which We are Queen.

It is further ordained that members, of any rank, of a Foreign Naval, Military or Air Force, or those of Commonwealth States of which We are not Queen who have been associated with operations of Our Naval, Military and Air Forces shall be eligible for the award of the Military Cross on the recommendation of Our Secretary of State for Defence with the agreement of the appropriate Minister of State of the said Foreign country or Commonwealth State.

*Fifthly:* It is ordained that the Decoration may be awarded posthumously.

#### GREETING!

WHEREAS His late Majesty King George VI, by Warrants under His Sign Manual dated 22nd September 1940, 11th March 1941, 23rd February 1942 and 10th November 1942, did amend and consolidate the regulations governing the Decoration called the Distinguished Flying Cross;

AND WHEREAS We, by Warrants under Our Sign Manual dated 15th July 1955, 27th July 1968 and 22nd May 1980, did further amend the regulations governing eligibility for the said Decoration;

AND WHEREAS We deem it expedient to amend the regulations further to allow members of any rank in Our Armed Forces to receive the said Cross;

NOW, THEREFORE, We do declare that the regulations promulgated in the aforementioned Warrants in respect of the Distinguished Flying Cross shall be abrogated, cancelled and annulled; and in substitution thereof We by these Presents for Us, Our Heirs and Successors, are graciously pleased to make, ordain and establish the following rules and ordinances, which shall from henceforth be inviolably observed and kept.

*Firstly:* It is ordained that the Decoration shall be designated and styled the "Distinguished Flying Cross".

*Secondly:* It is ordained that the Decoration shall consist of a Cross flory terminated in the horizontal and base bars with bombs and in the upper bar with a rose, surmounted by another cross composed of aeroplane propellers charged in the centre with a roundel within a wreath of laurels a rose winged ensigned by an Imperial Crown thereon the letters RAF; that the reverse of the Cross shall be plain and shall bear the Royal Cypher above the date 1918 and the rank, name and Service, Regiment or Corps, customarily appropriate to the recipient and the date of the award; that the Cross shall be suspended by a ring from a bar consisting of two sprigs of laurel; and that the whole shall be in silver.

*Thirdly:* It is ordained that the Decoration shall be worn on the left breast suspended on a ribbon one-and-a-quarter inches in width of violet and white in alternate diagonal stripes one-eighth of an inch in width running at an angle of 45 degrees downwards towards the wearer's left.

It is further ordained that in the official list showing the order in which Orders, Decorations and Medals are to be worn it shall be placed immediately after the Military Cross.

*Fourthly:* It is ordained that the Decoration shall be awarded in recognition of an act or acts of exemplary gallantry while flying during active operations against the enemy to all members, of any rank, of Our Naval, Military or Air Forces on the recommendation of Our Secretary of State for Defence or the appropriate Minister of State of the other Realms and Territories of which We are Queen.

It is further ordained that members, of any rank, of a Foreign Naval, Military or Air Force or those of Commonwealth States of which We are not Queen who have been associated with operations of Our Naval, Military and Air Forces shall be eligible for the award of the Distinguished Flying Cross on the recommendation of Our Secretary of State for Defence with the agreement of the appropriate Minister of State of the said Foreign country or Commonwealth State.

*Fifthly:* It is ordained that the Decoration may be awarded posthumously.

*Sixthly:* It is ordained that in the event of a person who has been awarded the Decoration again performing such an act or acts as would have entitled him or her to the Distinguished Flying Cross if he or she had not already received it, such further act or acts shall be recorded by a Bar attached to the ribbon by which the Decoration is suspended and for every further act an additional Bar shall be added. A rose Emblem denoting the award of each Bar shall be worn on the ribbon when the ribbon only is worn.
