CYCLE LANES

To remove the existing cycle track on the footway opposite the Constitution Public House, 42 St Pancras Way.
- To revoke the existing pay and display parking places in St Pancras Way on the east side, between Barker Drive and Wrotham Road.

THE GLOBE STREET NORTHEAST ACCESS (SOUTHWARK) (PROHIBITION OF TRAFFIC) EXPERIMENTAL (NO 121) TRAFFIC ORDER 2002

Made—8 November 2002

Coming into force—29 November 2002

The Council of the London Borough of Southwark after consulting with the Commissioner of Police of the Metropolis and with the consent of the Traffic Director for London, in exercise of the powers conferred by section 9 of the Road Traffic Regulation Act 1984, and of all other enabling powers, hereby makes the following Order:

1. This Order may be cited as The Globe Street Northeast Access (Southwark) (Prohibition of Traffic) Experimental (No 121) Traffic Order 2002 and shall come into force on 29 November 2002.
2. This Order is made to prohibit entry into or egress from Globe Street northeast at its junction with Great Dover Street, as shown on the plan.
3. No person shall cause or permit any vehicle to exit or enter Globe Street northeast access to or from Great Dover Street.

4. (1) The provisions specified in article 3 above shall not apply in respect of:

- (i) any vehicle being used for the purpose of those works, or for fire brigade, ambulance or police purpose in an emergency; or
- (ii) anything done with the permission or at the direction of a police constable in uniform or a traffic warden;
- (iii) a pedal bicycle or pedal tricycle not being in either case capable of being mechanically propelled.

5. The Order provides that in pursuance of section 10(2) of the Road Traffic Regulation Act 1984 the Transport Group Manager or some persons authorised in that behalf, by them, may if it appears to them or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for the preserving or improving the amenities of the area through which the roads affected by the Order runs, modify or suspend the Order or any provision thereof.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Trinity Street (Southeast section) (Southwark) (Prescribed Route) (One Way) Experimental Order 2002/123 shall have the effect as though that:

(a) In Trinity Street, between its junctions with Falmouth Road and Great Dover Street, vehicles shall be prohibited from travelling in any direction other than from north-west to south-east.

3. Nothing in Article 2 of this Order shall apply in relation to:

- (a) To anything done with the permission or at the direction of a police constable in uniform, or
- (b) To any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or 67 of the Road Traffic Regulations Act 1984.
- (c) A pedal bicycle or pedal tricycle not being in either case mechanically propelled.
