#### ROAD TRAFFIC REGULATION ACT 1984

#### THE A435 TRUNK ROAD (GORCOTT HILL TO STUDLEY, WARWICKSHIRE) (RESTRICTION AND 40 MILES PER HOUR SPEED LIMIT) ORDER 2002

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 82(2), 83(1) and 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 on the A435 Trunk Road between Gorcott Hill and Studley in the County of Warwickshire.

The effect of the Order, which comes into force on 2 December 2002, will be to impose:

- (a) a 30 miles per hour speed limit on the trunk road between points 285 metres and 406 metres south-west of its junction with the centre line of Icknield Street Drive, and
- (b) a 40 miles per hour speed limit on the A435 Trunk Road from a point 300 metres north-east of its junction with the centre line of Common Lane to a point 285 metres south-west of its junction with the centre line of Icknield Street Drive.

#### ROAD TRAFFIC REGULATION ACT 1984

#### THE A30/A303 TRUNK ROAD (HONITON TO MARSH) (50 MPH SPEED LIMIT) ORDER 200

The Secretary of State for Transport hereby gives notice that he proposes to make the above-mentioned Order under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 on the A30/A303 Trunk Road in the district of East Devon, in the county of Devon.

The effect of the Order would be to impose a 50 mph speed limit on two lengths of the A30/A303 between Honiton and Marsh in the district of East Devon, in the county of Devon. The first, a distance of 1,640 metres, is from a point 157 metres east of the junction with Cheney's Lane, Honiton, to a point 97 metres north-east of the junction with the C352 at Ford Cross, Monkton. The second length, a distance of 10,200 metres eastbound and 10,300 metres westbound, is from a point 964 metres north-east of the junction with the C352 at Ford Cross to a point that is 485 metres south-west of the centre of Marsh junction underbridge, Marsh, on the eastbound carriageway and 582 metres south-west of the same underbridge on the westbound carriageway. The speed limit at Monkton, between these two lengths of road, would remain unchanged at 40 mph.
