ROAD TRAFFIC REGULATION ACT 1984

THE A465 TRUNK ROAD (BELMONT ROAD, HEREFORD) (RESTRICTION) ORDER 200

The Secretary of State for Transport hereby gives notice that he intends to make an Order under sections 82(2), 83(1) and 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984 on the A465 Trunk Road, known as Belmont Road, in the City of Hereford.

The effect of the Order would be to impose a 30 miles per hour speed limit on the A465 from a point 100 metres south-west of the centre of its roundabout junction with Southolme Road/Northolme Road/Abbotsmeade Road, known as Belmont Roundabout, to a point 145 metres south-west of its junction with Goodrich Grove.

THE A40 TRUNK ROAD (LEA, HEREFORDSHIRE) (RESTRICTION) ORDER 200

The Secretary of State for Transport hereby gives notice that he intends to make an Order under sections 82(2), 83(1) and 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984 on the A40 Trunk Road at Lea in the district of the County of Herefordshire.

The effect of the Order would be to impose a 30 miles per hour speed limit on the A40 from a point 100 metres west of its junction with the B4224 to a point 727 metre south-east of its junction with The Old Granary.
