THE A64 TRUNK ROAD (RAINTON CROSSROADS) (PROHIBITION OF USE OF GAP IN CENTRAL

Notice is hereby given that the Secretary of State for Transport proposes to make an Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A1 Trunk Road in the District of Harrogate in the county of North Yorkshire.

1. Notice is hereby given that the London Borough of Ealing on 12 December 2002 made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

2. The general effect of the Orders would be:

(a) to introduce a 24 hour bus lane in Coronation Road, NW10 in the northernmost eastbound lane, between a point 53.5 metres east of the eastern kerbline of Britannia Way and a point 2.5 metres west of the front western flank wall of No 857 Coronation Road and to provide that only buses and pedal cycles may use the lane; (b) to introduce lengths of 24 hour cycle lanes in Coronation Road

NW10 on the north and north-east side, between the Borough boundary with the London Borough of Brent and a point 12 metres south-east of a point opposite the common boundary of Nos 859 and 860 Coronation Road and between a point 2 metres west of the western flank wall of No 857 Coronation Road and a point 38 metres east of that same flank wall and to provide that only pedal cycles may use the said lanes;

(c) to relocate the 24 hour bus stop clearway on the northern side of Coronation Road lying 59 metres west of the western kerbline of Western Road to a point opposite that western kerbline extending westwards for a distance of 19 metres;

(d) to ban U-turns around the new central island site opposite the junction with Western Road;

(e) to introduce further lengths of any time waiting restrictions on the south side of Coronation Road between the Borough boundary with Brent and the junction with Park Royal Road with areas for free unrestricted parking within these;

(f) to introduce waiting and loading restrictions applying at any time on the north side of Coronation Road, in the lengths of bus lane specified in paragraph 2(a) above; and

(g) to introduce waiting restrictions applying at any time on the north side of Coronation Road in the length of the cycle lane specified in
