THE TRUNK ROADS A5/A55 (VARIOUS LAY-BYS, CLWYD) (RESTRICTION OF WAITING) ORDER 1986 (VARIATION) ORDER 2003

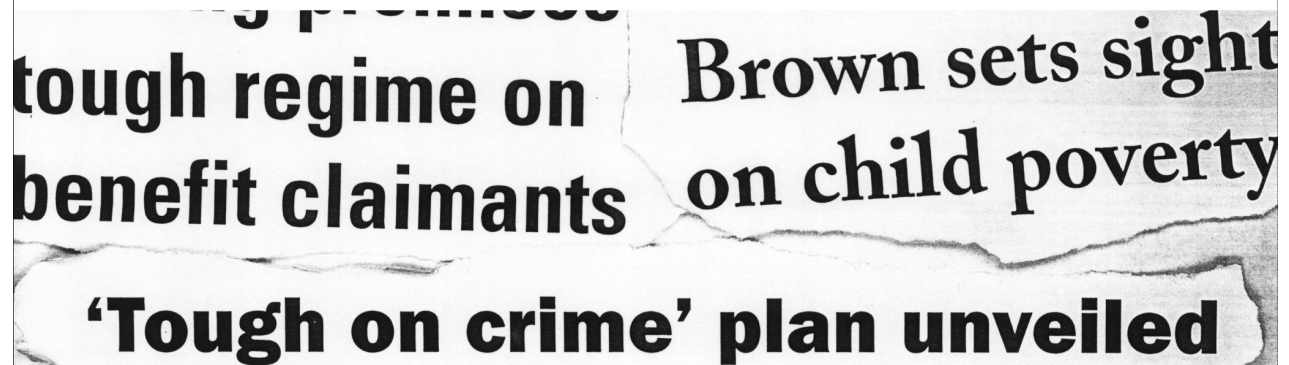
