- 1. Notice is hereby given that the Council of the London Borough of Croydon propose to make the Croydon (Waiting and Loading Restriction) (Amendment No A48) Traffic Order 2003, under sections 6 and 124 of, and Part IV of, Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.
