PROPOSED WAITING RESTRICTIONS IN VARIOUS LOCATIONS AND FREE PARKING BAYS IN LINTON GLADE

- 1. Notice is hereby given that the Council of the London Borough of Croydon, propose to make Traffic Orders under the relevant sections of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.
- 2. The general effect of the Croydon (Waiting and Loading Restriction) (Amendment No A66) Order would be to further amend the Croydon (Waiting and Loading Restriction) Order 2001 so that waiting by vehicles, otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle, would be prohibited:
- (a) at any time throughout the week in those lengths of streets specified in Schedule 1 to this notice;

- 3. The general effect of the Croydon (Linton Glade) (Free Parking Places) (Amendment No A65) Traffic Order 2004 would be to introduce free parking places in Linton Glade as specified in Schedule 4 to this notice
- 4. The prohibition referred to in paragraph 2 above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, eg the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc, from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Badge" will apply.
- 5. The Order is intended to introduce waiting restrictions "At any time" throughout the week in lengths of Ashdown Gardens, Biggin Hill, Biggin Way, Bridle Road, Chertsey Crescent, Cleves Crescent, Cresswell Road, Downsview Gardens, Euston Road, Grafton Road, Graham Close, Harrington Road, Limpsfield Road, Linton Glade, Overbury Crescent, Parker Road, South End, Wickham Avenue and waiting restrictions between 7.00 am and 7.00 pm Monday to Saturday inclusive in lengths of Long Lane and Spring Lane. In Onslow Gardens a length of waiting restriction between 8.00 am to 6.30 pm Monday to Saturday inclusive would be introduced. Free parking bays in Linton Glade would also be introduced at safe locations away from junctions and driveways. The restrictions would ensure adequate visibility for motorists emerging from junctions, that pedestrians crossing minor roads can see and be seen and turning vehicles have sufficient manoeuverability.
