##### ROAD TRAFFIC REGULATION ACT 1984

##### THE A46 TRUNK ROAD (TORMARTON LAYBYS) (WAITING RESTRICTION) ORDER 2004

The Secretary of State for Transport hereby gives notice that he made this Order on 21 January 2004, coming into force on 2 February 2004, on the A46 Trunk Road in South Gloucestershire.
