# PROPOSED "AT ANY TIME" WAITING RESTRICTIONS—VARIOUS LOCATIONS

- 1. Notice is hereby given that the Council of the London Borough of Croydon propose to make the Croydon (Waiting and Loading Restriction) (Amendment No J7) Traffic Order 2004 under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.
- 2. The general effect of the Order would be to further amend the Croydon (Waiting and Loading Restriction) Order 2001 so that waiting by vehicles, otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle, would be prohibited:

The prohibition referred to in paragraph 2 above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, eg the picking up or setting down of passengers; the carrying out of statutory powers of duties; the taking in of petrol, etc, from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying disabled person's "Badge" will apply.

THE CROYDON (FREE PARKING PLACES) (NEIGHBOURHOOD CARE CONCESSIONARY PERMIT) (NO 1) TRAFFIC ORDER 2004

- 1. Notice is hereby given that the London Borough of Croydon on 29 March 2004 made the above-mentioned Orders under section 6 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.
- 2. The general effect of the Croydon (Ambulance Vehicles) (Free Parking Places) (No 1) Traffic Order 2004 would be:
- (a) to designate a free parking place in High Street, Croydon as specified in Schedule 1 to this notice;
- (b) to provide that the parking place would be in operation at any time throughout the week;

- (c) to specify that the use of the parking place will be restricted to marked ambulance vehicles only; and
- (d) to provide that the parking place may be suspended when necessary to facilitate emergencies or the carrying out of special functions.
- 3. The general effect of the Croydon (Free Parking Places) (Neighbourhood Care Concessionary Permit) (No 1) Traffic Order 2004, would be:
- (a) to designate free parking places in Norbury Crescent and Oakhill Road, Norbury and Russell Hill, Purley;
- (b) to provide that the parking places in Norbury Crescent and Oakhill Road as specified in Schedule 2 to this notice would be in operation at any time throughout the week;
- (c) to provide that the parking place in Russell Hill as specified in Schedule 3 to this notice would be in operation between 9.00 am and 5.00 pm Mondays to Saturdays inclusive;
- (d) to specify that the use of the parking places will be restricted to passenger vehicles for which a Neighbourhood Care concessionary permit has been issued by the Council; and
