LONDON STREET/MARK LANE, PROPOSED TRAFFIC MEASURES

1. Notice is hereby given that the Common Council of the City of London, on 20 August 2004, made Orders under sections 6 and 45 of the Road Traffic Regulation Act 1984.

2. The proposals are in connection with a street scene enhancement programme in the vicinity of Fenchurch Street Station.

3. The effect of the Orders will be to:

- (a) close to all vehicles the north to south arm of London Street;
- (b) restore two-way working for vehicles in Mark Lane, between Fenchurch Street and London Street;
- (c) permit the right turn by vehicles from Mark Lane into Fenchurch Street;
- (d) alter the hours during which the restrictions on waiting by vehicles on the east side of Mark Lane (between Fenchurch Street and London Street) apply so that they will apply at any time;
- (e) remove metered, disabled persons and motorcycle parking in Mark Lane and relocate in alternative locations in Mark Lane, London Street and Crutched Friars.

4. A copy of each of the Orders which will come into operation on 31 August 2004, and of a plan showing the affected streets can be inspected during normal office hours on Monday to Fridays until the end of 6 weeks from the date on which the Orders were made in the Department of Planning and Transportation, Guildhall, London EC2P 2EJ.

5. Copies of the Orders may be obtained from the above address or by telephoning the Department of Planning and Transportation on 0207 332 1108.

6. Any person desiring to question the validity of any of the Orders or of any provision contained therein on the ground that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.
