GRAVEL LANE—RELOCATION OF A MOTOR CYCLE BAY BUSH LANE/CLOTH FAIR/CORNHILL/GOPHIR LANE/ROOD LANE—CHANGES TO WAITING AND LOADING RESTRICTIONS

1. Notice is hereby given that the Common Council of the City of London on 26 November 2004 made Orders under sections 6 and 45 of the Road Traffic Regulation Act 1984.
