THE A556 TRUNK ROAD (BUCKLOW HILL JUNCTION, RIGHT TURN LOOP) (50 MILES PER HOUR SPEED LIMIT) OPDER 200

The Secretary of State for Transport gives notice that he proposes to make an Order under sections 84(1)(a) and (2) and 122A(1) and (2) of the Road Traffic Regulation Act 1984.

The Order, if made as proposed, will impose a 50 miles per hour speed limit on the A556 Trunk Road (Chester Road) at Bucklow Hill in the county of Cheshire, from a point at the commencement of the proposed new right turn loop (to be situated 88 metres south of the junction with the A5034 Mereside Road) to a point at the end of the right turn loop, a total distance of 194 metres.

PROPOSED "AT ANY TIME" WAITING RESTRICTIONS IN VARIOUS LOCATIONS

- 1. Notice is hereby given that the Council of the London Borough of Croydon propose to make the Croydon (Waiting and Loading Restriction) (Amendment No A5) Traffic Order 2005 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act, 1984 as amended by the Local Government Act, 1985.

These restrictions are to ensure adequate visibility for motorists emerging from junctions, that pedestrians crossing minor roads can see and be seen, to prevent obstructive parking and allow turning vehicles sufficient manoeuverability.
