Take notice that Anglian Water Services Limited of Henderson House, Lancaster Way, Huntingdon, Cambridgeshire PE29 6XQ, is applying to the Environment Agency to vary licence 7/34/13/G/0186 to abstract water from two boreholes in the Chalk at National Grid Ref TG186087 in the Parish of Bowthorpe in the district of South Norfolk in the county of Norfolk.

The proposal is to renew abstraction at the following rates: 250 cubic metres per hour, 6,000 cubic metres per day and 1,228,000 cubic metres per year. This water will be used for public water supply and will otherwise reduce on 31st December 2005. In addition it is proposed to renew abstraction at the following rates: 54 cubic metres per hour, 1,296 cubic metres per day and 234,000 cubic metres per year. This water will be used for marsh support and will otherwise cease on 31 December 2005.
