New Roads and Street Works

London Borough of Tower Hamlets

NEW ROADS AND STREET WORKS ACT 1991, SECTION 58 NOTICE OF SUBSTANTIAL WORK

1. Three months advance notice is hereby given that London Borough of Tower Hamlets intends to carry out substantial road works.
2. The streets in which these works will take place are Tredegar Road at its junction's with Fairfield Road and Wick Lane (by the slip roads to the A12 East Cross Route). The area of works are:

(a) the length of Tredegar Road between Parnell Road and Wick Lane.
(b) Fairfield Road from Tredegar Road and a point 75 metres south.

3. The work will affect the existing carriageway and footway over the whole width of the above area of the public highway.

4. Work is expected to commence on 18 January 2006.

5. The works notified will include the reconstruction of footway and carriageway, realignment of kerbs, adjustment of EDF existing ducts.

6. Subject to the exemption in the Act and Regulations under it, no street works may be executed for a period of 12 months from the completion of the works described in paragraph 2 without the consent of the said Highway Authority, which shall not be unreasonably withheld.

NEW ROADS AND STREET WORKS ACT 1991, SECTION 58 NOTICE OF SUBSTANTIAL ROAD WORK

NEW ROADS AND STREET WORKS ACT 1991, NOTIFICATION OF SUBSTANTIAL ROAD WORKS

In accordance with section 58 of the New Roads and Street Works Act 1991 advance notice is hereby given that Transport for London (Highway Authority) intends to carry out substantial works for road purposes.

The streets in which these works will take place is A232 Acre Lane and Croydon Road in Sutton (Post Code SM6) from the junction with Harcourt Road to a point 100 metres west of Manor Road and A237 Manor Road and Manor Road North from the junction with Wrights Row to a point 60 metres north of Acre Lane.

The works will include reconstruction (up to 650 mm deep) and resurfacing works on the whole width of the carriageway.

Work is expected to commence on 16 January 2006 and affect the carriageway between late January 2006 and February 2006.

Subject to the exemptions in the Act and regulations under it, no street works may be executed for a period of 12 months from completion of the works described above without the consent of the said Highway Authority, which shall not be unreasonably withheld.
