### **PROPOSAL TO DESIGNATE NEW DISABLED PERSONS' PARKING PLACES AND FORMALLY DESIGNATE AND REVOKE EXISTING DISABLED PERSONS' PARKING PLACES**

(This notice is about the Council's proposal to designate new and existing disabled persons' parking places in certain roads in the borough and to remove certain disabled persons' parking places that are no longer required in the borough. Objections may be made, see paragraph 6)

### **PROVISION OF A FREE LIMITED TIME PARKING PLACE IN CROWN DALE AND WAITING RESTRICTIONS CROWN DALE, CROWN LANE AND KNIGHT'S HILL**

(This notice is about the Council's proposal to provide a free limited time parking place in Crown Dale and vary the waiting and loading restrictions in the above roads as part of the improvements at the junction of Beulah Hill, Crown Dale, Crown Lane and Knight's Hill. Objections may be made—see paragraph 7.)

1. Notice is hereby given that Lambeth Borough Council propose to make the Lambeth (Waiting and Loading Restriction) (Special Parking Area) (Amendment No ) Order 2006, the Lambeth (Waiting and Loading Restriction) (Amendment No ) Order 2006 and the Lambeth (Free Parking Places) (Limited Time) (No ) Order 2006 under sections 6 and 124 of the Road Traffic Regulations Act 1984.

2. In brief, the general effect of the Orders would be to:

(a) provide a free limited time parking place in Crown Dale, on the north side, from a point 25 metres east of Knight's Hill and a point 11 metres west of No 1 Crown Dale, which may be used between 10.00 am and 4.00 pm, Mondays to Saturdays inclusive, for a maximum period of 20 minutes, with no return to the parking place within 1 hour of leaving it;

(b) ban waiting by vehicles and to ban the loading and unloading of vehicles at any time in the lengths of Crown Dale, Crown Lane and Knight's Hill, specified in Schedule 1 to this notice;

(c) ban waiting by vehicles between 8.00 am and 6.30 pm, Mondays to Saturdays inclusive, in the lengths of Crown Dale and Crown Lane, specified in Schedule 2 to this notice;

(d) ban the loading and unloading of vehicles between 8.00 am and 9.30 am and 4.30 pm and 6.30 pm on Mondays to Fridays in the lengths of Crown Dale and Crown Lane, specified in Schedule 3 to this notice; and

(e) ban waiting by vehicles between 8.00 am and 10.00 am and 4.00 pm and 6.30 pm, Mondays to Saturdays in that length of Crown Dale which lies between a point 25 metres east of Knight's Hill and a point 11 metres west of No 1 Crown Dale.

3. Any existing prohibitions on waiting by vehicles in the lengths of streets specified in paragraph 2(b), (c), (d) and (e) above would be revoked.

4. The Orders are necessary to prevent parking which obstructs access and hinders the free flow of traffic whilst encouraging a turnover for trade and shops in the area.
