THE GREENWICH (FREE PARKING PLACES) (DISABLED PERSONS) (AMENDMENT NO) ORDER 200

1. Notice is hereby given that Greenwich Council, hereinafter called the Council, propose to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order would be to further amend the Greenwich (Free Parking Places) (Disabled Persons) Order 1994 so as to:

(a) designate disabled persons parking places, specified in the Schedule to this notice, in which vehicles displaying a valid disabled persons badge may be left;

(b) remove the disabled persons parking places, situated outside No 34 Ankerdine Crescent, No 78 Howarth Road and No 167 McLeod Road.

A copy of the proposed Order, the Order being amended and the Council's statement of reasons for proposing to make the Order together with plans showing the locations and effects of the Order can be inspected during normal office hours on Mondays to Fridays inclusive, until the end of 6 weeks from the date on which the Order is made or as the case may be, the Council decides not to make the Order, at Greenwich Transportation & Highways, Strategic Planning Department, Greenwich Council, Peggy Middleton House, 50 Woolwich New Road, Woolwich SE18 6HQ.
