

## SCHEDULE

*Description of land and the new rights**In Longendale in the Metropolitan Borough of Tameside*

Rough grazing land and half bed of stream on the east and north of the M67 eastern terminal roundabout, east of Grange Farm buildings. The right to enter upon rough grazing land and half bed of stream on the north east of the M67 eastern terminal roundabout on the east of Grange Farm buildings, for all purposes in connection with the construction and maintenance to headwall and drainage pipes and to cleanse widen and deepen existing ditch (All owned by Mrs J L Cox) (plots 1/1; 1/1A; 1/1B; 1/1C; 1/1D);

Grazing land, part of public footpaths LON/50, LON/51 and LON/52, pond, part of stream, half bed of stream and part of disused cricket ground on the north east and east of M67 eastern terminal roundabout, east and south east of the Grange Farm Buildings, north and north east of A57 Hyde road, south west and south east of Old Mill Farm, south west, west, north and north west of the disused cricket ground, west of the properties known as 30 and 40 Four Lanes, east of Mainsgrass Farm on the west and southwest of Roe Cross Road and on the west of Hobson Moor Road; scrubland and former quarry on the west of the junction of Hobson Moor Road and Roe Cross Road;
