THE CAMDEN (WAITING AND LOADING RESTRICTIONS) (AMENDMENT NO 157) ORDER 2006

THE CAMDEN (PARKING PLACES) (CA-F) (AMENDMENT NO 25) ORDER 2006

Notice is hereby given, that the Council of the London Borough of Camden propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

The general nature and effect of the Orders will be:

- (i) to remove the existing double yellow line and introduce an additional residents parking place, 55 metres in length outside Donnington Court, Castlehaven Road;
- (ii) to convert an existing pay & display parking place to include resident/shared-use, between 7-19 Greenland Road;
- (iii) to extend some resident parking places in Gloucester Crescent and Inverness Street to provide additional spaces;
- (iv) to re-schedule two existing pay & display bays in Parkway to update their location:
- (v) to relocate the residents parking place in Dalby Street to the west side, introduce three disabled persons parking places and re-designate the double yellow line to the east side;
- (vi) to designate two "ambulance" only bays in Grafton Way and Tottenham Court Road;
- (vii) to relocate one resident parking space from the north-east side outside No 54 to the south-west side outside No 39 in Hawley Road; (viii) to introduce a new free motorcycle parking place in Mornington Terrace, opposite the northern kerbline of Mornington Place.

PROPOSED 20 MPH SPEED LIMIT IN ATHERTON PLACE, BURNS AVENUE, CARLYLE AVENUE (PART), DORMERS WELLS LANE (PART), FARM CLOSE, GREENFIELDS KENTON AVENUE, KINGSLEY AVENUE, LONGFORD AVENUE, MARK CLOSE, MASEFIELD AVENUE (PART), MEADOW ROAD, MELROSE DRIVE, MILFORD ROAD, NORTH AVENUE (PART), NORTH ROAD (PART), OAKWOOD AVENUE, PALGRAVE AVENUE, PARK VIEW ROAD, SCHOOL PASSAGE, SHACKLETON ROAD (PART), SHRUBBERY ROAD, STAMFORD CLOSE AND WAVERLEY ROAD, SOUTHALL WITH ASSOCIATED TRAFFIC CALMING MEASURES

- 1. Notice is hereby given that the London Borough of Ealing propose to make the above mentioned Orders under sections 6, 45, 46, 49, 84 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Speed Limit Order would be to introduce a 20 mph speed limit in Atherton Place, Burns Avenue, Carlyle Avenue (part), Dormers Wells Lane (part), Farm Close, Greenfields, Kenton Avenue, Kingsley Avenue, Longford Avenue, Mark Close, Masefield

Avenue (part), Meadow Road, Melrose Drive, Milford Road, North Avenue (part), North Road (part), Oakwood Avenue, Palgrave Avenue, Park View Road, School Passage, Shackleton Road (part), Shrubbery Road, Stamford Close and Waverley Road

- 3. The general effect of the Waiting Restriction Order would be to introduce waiting restrictions applying at any time in the lengths of roads specified in the Schedule to this Notice.
- 4. The general effect of the Free Parking Place Order would be to provide a free parking place in North Road outside Nos 6 to 17/18 North Parade where vehicles may park with four wheels on the footway with no time restriction.
- 5. It is proposed under the powers of section 90c of the Highways Act 1980 to introduce:
- (a) a series of road humps each with a nominal height of 75 mms and longitudinal width of 3.70 metres in
- (i) Dormers Wells Lane in the vicinity of No 10, Nos 9 to 16 Blackthorne Court, approximately 25 metres north of the northern extremity of the island at the junction of Uxbridge Road and in the main carriageway of Dormers Wells Lane opposite No 65;
- (ii) Kenton Avenue in the vicinity of No 10 and Nos 24 and 26;
- (iii) Kingsley Avenue, 1 metre north-east of the party wall of Nos 7 and 9 and in the vicinity of No 33;
- (iv) Longford Avenue in the vicinity of Nos 31 and 33, Nos 22/23 Addison Place, 4.8 metres north of No 10, and Upton Court;
- (v) Masefield Avenue in the vicinity of No 8 and No 40;
- (vi) Meadow Road, in the vicinity of Nos 25 and 27;
- (vii) Milford Road, in the vicinity of No 61, Nos 34 and 36 and Nos 9 and 11:
- (viii) North Avenue in the vicinity of Nos 25 and 27, Nos 7 and 9;
- (ix) North Road in the vicinity of No 10, Nos 40 and 42, No 55, Nos 72 and 74, a point 32.2 metres north-east of the south-western kerbline of the triangular island site, Nos 96 and 98, Nos 109 and 111, Nos 113 and 115 and Nos 123 and 125;
- (x) Oakwood Avenue in the vicinity of Nos 58 and 60, Nos 15 and 17 and No 3;
- (xi) Palgrave Avenue in the vicinity of No 8, No 39 and 5.4 metres north of No 67;
- (xii) Park View Road in the vicinity of Nos 15 and 16 and near the western boundary of No 11;
- (xiii) Shackleton Road in the vicinity of Nos 36 and 38 and Nos 8 and 10;
- (xiv) Shrubbery Road in the vicinity of No 15; (xv) Waverley Road approximately 7.3 metres north of the rear boundary between No 66 Burns Avenue and No 15 Kenton Avenue;
- (b) a series of cushion humps each with a nominal height of 75 mms, lengths of 2 metres and widths of from 1.6 to 2 metres
- (i) Burns Avenue in the vicinity of No 143 (3 cushions), No 125 (3 cushions), No 111 (3 cushions), Nos 79 and 81 (3 cushions), No 55 (3 cushions), No 41 (3 cushions), No 7 (3 cushions),
- (ii) Carlyle Avenue in the vicinity of No 18 (2 cushions), No 38 (2 cushions)
