#### THE A249 TRUNK ROAD (IWADE BYPASS TO QUEENBOROUGH IMPROVEMENT) (24 HOURS CLEARWAY) ORDER 200

The Secretary of State for Transport hereby gives notice that he proposes to make Orders under sections 1(1), 2(1) and (2), 4(1), 82(2) and 83(1) of the Road Traffic Regulation Act 1984 on the A249 Trunk Road near Iwade and on the Isle of Sheppey in the borough of Swale in the county of Kent.

The effect of the Orders would be:

1. To revoke the 30mph speed restriction automatically imposed by the installation of street lighting on the new A249 Trunk Road from a point approximately 120 metres south of Cowstead Roundabout to Neatscourt roundabout, in both directions, a total distance of approximately 870 metres. The national speed limit would then apply on this length of road.

2. To impose a 24 hours clearway on the new A249 Trunk Road from a point approximately 400 metres south of the centre of the A249 Iwade Bypass northern terminal Roundabout (Kingsferry Interchange) to a point approximately 500 metres to the north of the junction between the new Trunk Road and Main Road (B2007), a total distance of approximately 6.05 kilometres (3.78 miles).
