#### ROAD TRAFFIC REGULATION ACT 1984

##### THE A12 TRUNK ROAD (STANWAY TO SPRING LANE, ESSEX) (DERESTRICTION) ORDER 2006

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984 on the A12 Trunk Road in Essex.

The effect of the Order will be to remove the 30 miles per hour speed limit automatically imposed by the installation of street lighting and restore the national speed limit of 70 miles per hour on the following lengths of A12:

1. The A12 Trunk Road from a point 330 metres south of the centre point of King Coel overbridge to the centre point of Motts underbridge.
2. The A12 Trunk Road:

(a) northbound exit slip road from its junction with Spring Lane Interchange (Junction 27) to a point 230 metres north-east of that interchange, and

(b) southbound entry slip road from its junction with Spring Lane Interchange (Junction 27) to a point 185 metres north-east of that interchange.

1. Notice is hereby given that the Council of the London Borough of Enfield propose to make the Enfield (Waiting and Loading Restriction) (Special Parking Area) (Amendment No ) Order 200 , the Enfield (Prescribed Routes) (No ) Order 200 , and the Enfield (Weight Restriction) (No ) Traffic Order 200 under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:

(a) introduce new "at any time" waiting restrictions in parts of Centre Way, Goodwin Road, Montagu Road, North Way and South Way (note: the proposals would amend certain existing waiting restrictions currently operating there);

(b) ban vehicles exceeding 7.5 tonnes in weight from entering North Way;

(c) impose one-way traffic working for vehicles in:

(i) the north-eastern carriageway of Centre Way from north-west to south-east;

(ii) the south-western carriageway of Centre Way from south-east to north-west;
